5. NEW BUSINESS

5.1 Consultation – Amendment to Field Trip Policy

In response to a question from Rosemere High, Mrs. Maccarone responded that most of the tour operators do offer the service of collecting tips and they will make sure that those who are supposed to will receive them. Schools should make arrangements with the tour operator to have this in the contract.

In response to a question from Laval Junior Academy, Mrs. Maccarone responded that if students go on field trips via public transport, they are insured if something happens.

In response to a question from Laurentian Regional High School, Mrs. Maccarone responded that the field trip policy is a guideline and it is internal policy in schools to plan and execute their field trips as long as due diligence is followed. The 30 day requirement applies mainly to out of country/province trips.

In response to a question from Rosemere High on the terms in 7.2 specifically the word "annoyance", Mrs. Maccarone responded that in updating this policy, the Information Technology department did research and looked at other boards to make sure we were compliant and they may have picked up on dialogue to be sure everything was covered. If members are not comfortable with the word they can ask for it to be removed in their comments.

6. REPORTS

6.1 School Board's Report

- The CRC Robotics competition is being hosted at Laval Senior Academy February 1-3. More than 600 students from across the province from high school and CEGEP are competing. Lake of Two Mountains and Laval Senior Academy are participating from our board this year.
- SWLSB will receive 10.5 million dollars from the ministry for infrastructure funding. All of the projects that were submitted
 have been accepted. Each of the 3L territories are covered in this. Mrs. Maccarone highlighted all of the projects.
- Council is working on the strategic plan that will take us through the next 5 to 7 years. Information will go out to all stakeholders for community events to ask for everyone's opinion. Early intervention, success rates, will be looked at. By 2020 they would like a 90% success rate. The targets set by the ministry are graduation and qualification, equity, (strategies to bridge gaps in order for everyone to be successful), special needs success, educational path and infrastructure. In addition to these our board will add to them. We will be going out to the public to see what it is that parents and students want to focus on for the strategic plan. It will be a fast consultation as it needs to be deposited by June. We are looking at having 3 different town halls and online surveys to make it easy to give feedback.
- Working on the budget parameters for 2018-2019 school year.
- Parents will see the tax rate change on the next school tax bill. The rate will be the lowest rate in that region.
- Sergio Di Marco praised the SWL Foundation on a successful gala last week. The Foundation works hard to raise funds for students in our school. At this gala, over \$39,000 was raised for the students. The next event is the Lobster Gala on June 14. 100% of all money raised goes back into the schools. Congratulations to all members of the foundation.

7. VARIA

7.1 Student influx from Laval Junior and Senior towards Lake of Two Mountains High

There are many students from Laval wanting to go to Lake of Two Mountains. The big issue is transportation. Mrs. Maccarone responded that there is an STL bus that goes to Deux-Montagnes but there is only one stop. Parents would need to get their child to the bus stop in Laval and they would be transported to Deux-Montagnes.

8. QUESTION PERIOD

A parent is upset they were forced to pay a ped day daycare fee on the snow day even though it is their practice not to send their child to the daycare on ped days. Our Lady of Peace went on to say that on ped days parents do pay an extra charge but there is usually an activity planned and on snow days there is no activity. Mrs. Maccarone replied that on ped days we have to pay the extra hours for staff therefore there is an extra charge, but it is not for activities it is for extra staffing. When parents register for daycare, they are obliged to pay for every day that they are registered, even when their child does not attend. Therefore a snow day is considered a regular daycare day and if you do not bring your child you are still obliged to pay the fee for the day. In response to a question from Our Lady of Peace Elementary, the school daycare fee structure is not the same as the government funded daycares for preschool children. Mrs. Maccarone went on to say that she will look into getting a communication prepared on how daycares work so that parents understand what they are being charged for.

Souvenir Elementary praised the SWLSB APP and went on to say that many parents still do not know it exists.
