Minutes of the sixth ( $\left.6^{\text {th }}\right)$ meeting of the 2021-2022 ROSEMERE HIGH School Governing Board held on Tuesday, April 26, 2022 via ZOOM at 7:30 p.m.

The Vice-Chairperson called the meeting to order at 7:31 p.m.

## 1. Agenda - Additions and approval

## 2. Approval of the minutes of the meeting of March 15, 2022

GB20220426-02 Suzanne Charbonneau MOVED THAT the minutes of March 15, 2022 be approved.

## 3. Question period

In order to ensure a visible presence of administration (taking into consideration all of the other tasks required of administrators), and with next year's enrollment projection, could we not have an additional administrator added to the RHS team? Does our growth in numbers along with the additional issues brought on by the pandemic not warrant the hiring of another VP?

The committee entered into a lengthy discussion.
Eve Boucher spoke about how the disrespect and violence is happening more and more in the school and as a student she is appalled and respects staff for what they have to go through on a daily basis.

The parents will attend the Council of commissioners meeting on Wednesday to ask the following:

- The calculation for the number of administrators is based on weighted enrollment, ISME, number of buildings and number of staff;
- There has been an increase in bullying and acts of violence (58 in 2020-2021 and 80 so far in 2021-2022), videotaping of acts of violence which are then shared on social media;
- Observation of an increased lack of social skills, an increase of disrespect, an increase of vaping in the school, vandalism, verbal abuse to teaching and non-teaching staff;
- Many RHS parents and students sharing their concern with the great amount of issues which have arisen this year;
- RHS feeder schools are seeing an increase in numbers;
- RHS is on the cusp of having a $10 \%$ increase in student numbers (it seems as though we are only approximately 6-7 students away from this),
- The administration cannot properly implement the ABAV plan;
- The junior high school in Laval with 400 less students than RHS has 2 VPs ;

Can an additional administrator be added to Rosemere High School for the 2022-2023 school year?
What is being done to handle the increased violence in Cycle 1? What can we do as governing board members to help stop and prevent these incidences from occurring? There is a group of girls who handle conflict with violence lately. Administration has asked the police to come in and do a workshop. Admin is working with the head office to come up with a plan. Looking to next year and what can be brought in. A subcommittee was formed to develop a plan focused on fostering a community of respect. The head office is supporting us $100 \%$. They are fully on board helping us out. Parents should be speaking to their kids to discourage them from participating in events and filming things. Reassure parents that the school team is working on it. The challenges this year are things that RHS has never had to face before.

If there are repeat offenders who are having difficulty, and violence is coming in that did not happen until now, what happens to these students. Sometimes they need to start fresh somewhere else. Is that something that is considered? After secondary 2 students can go to Phoenix.

### 5.1 Code of Conduct 2022-2023

Emailed to members and discussed.
The changes:

- During unstructured time, personal electronic devices may only be used outside or off school grounds. Otherwise we will confiscate them during the day. A clear majority of staff is in favor of this.
- Cafeteria will provide utensils.
- Dress code remains the same except students may wear hats and hoods in school but have to remove it if requested by their classroom teacher.
- In response to a question from Angie Ladas, the dress code says no rips or any kind, this includes leotards, stockings, fish net stockings, etc. The goal is to completely desexualize the clothing, as long as you are covered.
- In response to a follow up question from Angie Ladas, where last Friday when students were asked to return to class earlier, some students could not get into their classroom because the doors were locked. Is there something in the emergency plan where if they are asked, that someone who has keys goes to the rooms so students can get in. On Friday it was an out of the ordinary situation, and the goal was achieved even though some students could not get into their classrooms right away.
- Teachers also voted to change the way lockers are assigned. In discussion with teachers there is difficulty in some areas where conflict can arise. It has been decided to assign by bank of lockers - 12 to 15 lockers Sec 1, next bank Sec 2 and so on. Every area will have every grade. There will no longer be a designated area by grade level. Teachers do not see that this will be a problem. Students asked that if it is possible could their lockers be close to areas where their classrooms are. Admin will try to make sure that the bank of lockers in the science area could be students who are science students. Some parents are a bit concerned about this. The principal responded that they went around to other schools to see what they do. Most of the problems occur between Sec 1 and 2.
