0.0 Opening of Meeting:

The Chair called the meeting to order.

1.0 Commitment-to-Success Plan:

WHEREAS the 2012-2017 Strategic Plan of the Sir Wilfrid Laurier School Board concluded on June 30, 2017;

WHEREAS the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) has developed a new plan for the improvement of student success in Québec by 2030;

WHEREAS the plan of the MEES has established objectives and orientations that all school boards must align with;

WHEREAS targeted groups were invited to take part in a pre-consultation process during the spring of 2018 in preparation for development of the plan;

WHEREAS the feedback received from the pre-consultation has allowed the Sir Wilfrid Laurier School Board to designate its objectives and orientations within the framework set out by the MEES;

WHEREAS the stakeholders of the Sir Wilfrid Laurier School Board will be invited to participate in a consultation to provide feedback on the objectives and orientations for this plan;

Commissioner Guy Gagnon MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board authorize for consultation the 2018-2022 Commitment-to-Success Plan, as contained in document #SWLSB-2018/05/16-CA-001:

AND THAT the Council of Commissioners authorize a 30-day consultation period beginning on May 17, 2018 and ending on June 15, 2018 with all stakeholders including the Governing Boards, Parents Committee, Laurier Teachers Union, Association québécoise des cadres scolaires – Sir Wilfrid Laurier Chapter, Sir Wilfrid Laurier Administrators' Association, Professionals, CSN-S18 and SEPB-Québec-FTQ Local 577.

The Chairperson advised of technical adjustments that need to be made to the Commitment-to-Success Plan before it can be released for consultation and is recommending that the resolution be amended so that the start of the consultation is delayed by one day. Commissioner Guy Gagnon accepted this amendment.

The Interim Director General noted that these changes would be made and that a one-day delay in the start of the consultation would not be a problem.

2.0 Request to the MEES to withdraw the provision for recovery of the school transportation surplus from the proposed 2018-2019 budgetary rules:

WHEREAS the MEES will only provide 37.6 percent of funding to the Sir Wilfrid Laurier School Board for school transportation in 2018-2019 and that the school taxes collected by the school board will cover the remaining 62.4 percent;

Process for Recruiting

WHEREAS the Council of Commissioners wishes to commence the recruitment and hiring of a Director General:

WHEREAS, in accordance with policy #2012-CA-21: Policy for the Recruitment and Hiring of a Director General and an Assistant Director General, section 4.1.1, the Council of Commissioners must select the method to be used for this process from the following:

- A) Carry out the process by itself;
- B) Carry out part of the process by itself and engage external support;
- C) Outsource the entire process and engage a Human Resources Consulting Firm to carry it out, in this case, only sections 4.1.2 and 4.8 shall apply.

Commissioner Dean Dugas MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board select method B to be used for the recruitment process of a Director General.

WHEREAS, in accordance with said policy, the Council of Commissioners must first consult with the Human Resources Committee in conformity with section 193.1 of the Education Act, and the Sir Wilfrid Laurier School Board Unions and Associations, on the specific criteria for the post of Director General:

AND THAT the position of Director General be posted internally or externally or both as follows:

- Via e-mail invitation only;
- On the Corporate Web site;
- Through the means of the education network;
- Through provincial or national newspapers; and/or
- Other appropriate means.

FURTHER THAT the Director of Human Resources be mandated to post this position from May 17, 2018 to May 31, 2018.

WHEREAS the discussions were held in camera:

WHEREAS the present Resolution is entered into without admission whatsoever, whether in facts, in law or liability, for the sole purpose to settle the litigation;

WHEREAS the constitutional protection of rights to professional secrecy, the protection of litigation privilege and the protection of settlement privilege;
