The Director General welcomed everyone present and wished all a wonderful school year. She continued by presented her monthly report noting:

- The goals and priorities for the 2019-2020 school year with respect to the Commitment-to-Success Plan (CTSP) and the action plan for the implementation of the Educational Projects of each school;
- The school board ranks at 8 out of the 72 school boards thanks to its graduation rate. This
 is a proud testament of the quality of the school board personnel that contribute to ensure
 student success. Congratulations to all;
- Professional growth is another goal for 2019-2020. Retention and support of quality employees is a part of this goal;
- Partnerships On March 29 and 30, 2020, the Sir Wilfrid Laurier School Board will be the
 first Anglophone school board to host the Salon "Mieux comprendre la diversité /
 Embracing Diversity" in English. More information on this salon will be provided at a later
 date. Sunday, March 29, 2020 will be for parents and Monday, March 30, 2020 will be for
 school board employees. Commissioners are more than welcome to attend;
- Budget priorities there has been a slight increase in the overall budget for 2019-2020 and a significant increase in the budget for dedicated and protected measures;
- Events:
 - August 16, 2019 Welcome back for the management team at CDC Pont-Viau. The plan for the management meeting for 2019-2020 is to meet at a different school or centre throughout the year;
 - Pre-Kindergarten at the end of August the school board was granted an additional pre-kindergarten class by the Ministère de l'Éducation et de l'Enseignement supérieur (MEES). We now have 18 classes for the 2019-2020 school year;
