0.2.1 Chapeau, les filles!

The Chairperson extended congratulations to Rachel Ducharme, Jenica-Teija Gagnieux-Trichas, Mitra Seifi and Katherine Seiler for being named finalists in the 2019 *Chapeau, les filles!* contest.

0.2.2 Makerspace at Grenville Elementary School

The Chairperson welcomed the Principal of Grenville Elementary School and two members of the school staff to the meeting.

The Principal of Grenville Elementary School extended the school's appreciation to the Director General for providing the means to make the Markerspace event available to all of the Laurentian schools. She also noted that this activity is very good for students with special needs.

The team from Grenville Elementary School (GES) reviewed the Makers Space event noting:

- There were 30 stations made up of 10 different challenges with each participant participating in four challenges;
- The goal of the event is to get students to teach students with the teachers observing;
- GES began to use this platform two years ago with the teachers agreeing to have one hour of class time per week set aside for this purpose;
- It brings real problem-solving into the classroom and it has touched students in many different ways as with Makers Space there is no right or wrong answer, so there is no fear of failure;
- Makerspace allows the students to complete the task their way rather than the conventional or expected way, which decreases frustration.

The Chairperson and the Director General congratulated the GES team on this innovative project.

0.2.3 **QESBA Presentation**

The Chairperson introduced and welcomed the President, Dan Lamoureux, and the Executive Director, Russell Copeman, of Quebec English School Board Association (QESBA) to the meeting.

The President and Executive Director of QESBA noting the following:

- QESBA represents nine English school boards, 100 000 students and 340 schools;
- QESBA has been meeting each school board on its own territory in order to learn the individual characteristics of each;
- The QESBA has a 900 000\$ budget of which 60% is salaries and benefits;
- QESBA has been involved in four parliamentary committees in the last six months for school fees, school taxes, Bill 21 and the Pre-Kindergarten program;
- QESBA is attempting to establish links with the Francophone communities outside of Québec, as they also fight for minority rights in order to exchange any expertise acquired;
- QESBA is preparing for the potential abolishment of school boards by the current Québec government. School boards lead by universal suffrage elections, which play a very important role in the education system and allows its stakeholders to have a voice. There is also increasing evidence that community involvement in schools and school boards increases student success.

In response to questions, the President and Executive Director of QESBA noted:

- QESBA has been in discussion with the FCSQ (Fédération des commissions scolaires du • Québec) about the potential abolishment of school boards;
- One of the outstanding features of the Sir Wilfrid Laurier School Board is its bilingual Vocational Training Centre, Construc-Plus in St-Eustache;
- QESBA meets with the MEES on a regular basis to discuss various dossiers;
- The Eastern Townships School Board has received funding for a new school in Drummondville:
- It is anticipated that there will be some controversy when the current government deposits a bill concerning the abolishment of school boards as it has not yet expressed how this will improve student success:
- APPELE-Québec (Alliance for the Promotion of Public English-language Education in Québec) has been created for the purpose of the anticipated bill to abolish school boards and chaired by former Member of the National Assembly, Geoffrey Kelly, APPELE-Québec did a Leger marketing survey of 1 000 Anglophones and the results showed that there is a strong attachment to elected school boards and strong opposition to them being replaced by service centres;
- QESBA will try to find a way so that a court challenge does not take place as it will be very costly and take anywhere from three to five years to resolve. The MEES would have to take the bill to court to see if it is constitutionally viable;
- QESBA has some strong legal arguments concerning the abolishment of school boards.

The Chairperson thanked the President and Executive Director of QESBA for their informative presentation.

7.3 Financial Resources

7.3.1 2019-2020 Initial Budget

The Director of Financial Resources presented and reviewed the 2019-2020 balanced budget highlighting the following;

- Revenues educational grants and measures have increased, Ministère de l'Éducation et de l'Enseignement supérieur (MEES) grants have been decreased, etc.;
- Expenses by activity educational activities such as teacher salaries and materials, the teacher envelope for youth, teaching support, administrative costs, buildings and maintenance, other expenses;
- 2019-2020 investment;
- Budget timeline for 2019-2020;
- There are 3.6 teacher posts in surplus;
- There are two measures that can be used for field trips;
- Administrative costs per department at the head office are similar to 2018-2019;
- The building and maintenance envelope has been increased due to the increased energy costs in the winter months.

In response to a question received during the question period at the May 22, 2019 meeting, the Director General noted that the cost of the AESOP system in 2018-2019 was approximately 17 651.55\$ and that 3,600 absences were covered. The data complied on the use of the AESOP system by this school board has shown it to be a success.

2019-2020 Initial Budget WHEREAS in accordance with the Education Act (CQLR, chapter I-13.3), the Sir Wilfrid Laurier School Board must adopt and submit to the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) its operating, investment and debt service budget for the 2019-2020 school year;

WHEREAS the budget is balanced for the 2019-2020 school year;

WHEREAS the adjusted standardized assessment of taxable immovables before exemption that was used to determine the balance subsidy was of \$9,486,441,713 on May 1, 2019, in accordance with the Education Act and the budgetary rules for the 2019-2020 school year;

WHEREAS the school tax proceeds, which were of \$14,102,259 on May 1, 2019, were determined by taking into account:

- an adjusted standardized assessment of taxable immovables of \$25,000 and less in the amount of \$37,180,740, and
- an adjusted standardized assessment of taxable immovables of more than \$25,000 in the amount of \$9,449,260,973;
