4.0 Reports from the Chairperson and the Interim Director General

4.1 Chairperson's Report:

The Chairperson presented her monthly report noting:

- The Sir Wilfrid Laurier Foundation and its commitment and support of the school board through its honouring of student achievement and fundraising to assist the schools and centres. The Foundation gives 100% of the funds raised back to the schools for pedagogical purposes;
- The Ministre de l'Éducation et de l'Enseignement supérieur and the President of the FCSQ (Fédération des commissions scolaires du Québec) were present at the Quebec English School Boards Association (QESBA) Spring Conference. This is a unique event in that administrators and elected officials have the chance to network;
- The inauguration of the Centre de formation Construc-Plus Vocational Centre. This bilingual Vocational Training Centre is the first of its kind in Québec. The centre offers an array of programs available in both English and French which allows students to learn bilingually;
- Advanced Student Leadership (ASL) this group volunteers across Laval and is currently looking at ways to have a similar program at the elementary schools which would continue into high school;
- Senate Committee on Official Languages This group is undertaking the revision of the Languages Act and the QESBA had a recent opportunity to make a presentation to this group. The presentation recommended strict transparency mechanisms and revisions to the Canadian Census that would make it more inclusive;
- Consultation of the Special Project School and the Commitment-to-Success Plan all feedback has been very much appreciated;
- School fees The Ministre has issued a directive with respect to the charging of school fees and this directive will have a direct impact on schools with respect to what can and cannot be charged. The 2018-2019 school year will be a transition year;
- Bill 144: An Act to amend the Education Act and other legislative provisions concerning mainly free educational services and compulsory school attendance this law will change the manner in which families are supported by school boards. High school students who are home-schooled will now be able to benefit from access to the school library, labs, etc. Religious communities will continue to have access to the English school boards;

4.2 Interim Director General's Report:

The Interim Director General presented his monthly report highlighting:

 Resource Allocation Committee (RAC) – The 2017-2018 school year was the inaugural year for the group and it held six meetings to establish its internal rules and to review the new measures, the changes to existing measures and to make recommendations to the Council for budget purposes for the 2018-2019 school year;

- The school board shares five programs with the Commission scolaire de la Seigneuriedes-Mille-Îles within the new Centre de formation Construc-Plus Vocational Centre. The centre has seen an increase in women applying for programs since its opening. Stephanie Smith, a student in the Carpentry Program in English, won the contest for the naming of the centre;
- QualificAction Emploi-Québec Laurentides has purchased additional English classes for 2018-2019;
- Adult Education Seventeen students from CDC Vimont have been accepted into CÉGEP for 2018-2019.

5.0 Business Arising:

5.1 Commitment-to-Success Plan:

The Chairperson noted that the feedback received was reviewed at a special meeting of the Corporate Committee last evening. Meetings will be held with the groups that provided feedback on the plan to provide background on why some recommendations were retained while others were not.

Commitment-to-Success WHEREAS the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) has developed a new plan for the improvement of student success in Québec by 2030;

WHEREAS all stakeholders including the Governing Boards, Parents Committee, Laurier Teachers Union, Association québécoise des cadres scolaires – Sir Wilfrid Laurier Chapter, Sir Wilfrid Laurier Administrators' Association, Professionals, CSN-S18 and SEPB-Québec-FTQ Local 577 were consulted on said plan and feedback was received and taken into consideration;

5.2 Special Project School:

The Chairperson noted that over the years, many parents have expressed the need for a special project school. It is hoped that the establishment of a special project school will provide the parents and students with what they are looking for so that requests for interboard agreements will decrease.

Special Project School WHEREAS the Sir Wilfrid Laurier School Board (SWLSB) has informed the Parents' Committee and the Governing Boards of the ongoing declining student enrolment and is seeking support to maintain and increase enrolment in its schools;

WHEREAS, over a number of years families have elected to leave the SWLSB for other educational programs;

WHEREAS the parents of the SWLSB feel that the school board has always been open to the ideas and opinions of parents, especially with respect to the educational priorities;

WHEREAS the SWLSB wishes to respond to the request of parents for a Special Project School to offer enriched programs with a special focus;

WHEREAS section 240 of the Education Act states:

"By way of exception, at the request of a group of parents and after consulting with the parents' committee, a school board may, with the Minister's approval, establish a school for the purposes of a specific project other than a religious project, subject to the conditions and for the period determined by the Minister.

The school board may determine the criteria for the enrollment of the students in that school."

WHEREAS the SWLSB is confident that a Special Project School will fulfill these needs and enhance school perseverance and increase the success rate;

WHEREAS the SWLSB wishes to establish a school under section 240 based on an educational project focused on a specific pedagogical approach or on a specific program and on a particular organization of the curriculum;

WHEREAS the SWLSB undertook a consultation process with the Parents Committee and the Governing Boards for a Special Project School from May 18, 2018 to June 18, 2018;

WHEREAS the feedback received from the Parents' Committee and the Governing Boards has been taken into consideration;

Parent Commissioner Bob Pellerin MOVED THAT, on the recommendation of the Corporate Committee, the Council of Commissioners of the Sir Wilfrid Laurier School Board mandate the Interim Director General to apply to the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) for a Special Project School based on the provisions established under section 240 of the Education Act;

AND THAT the Interim Director General also be mandated to request from the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) authorization for the educational project for said school be STEM (Science, Technology, Engineering, and Mathematics);

FURTHER THAT, after authorization from the Ministère de l'Éducation et de l'Enseignement supérieur (MEES), the Council shall determine location of the Special Project School.

6.1 Financial Resources

6.1.1 Recommendations of the Resources Allocation Committee:

The Chairperson thanked the Resource Allocation Committee (RAC) for all of the time and effort put into these recommendations.

The Interim Director General provided the following highlights of the recommendations from the RAC:

- The majority of the MEES measures are status quo and are now based on enrolment;
- The Management Committee will be informed in the Fall on the distribution of the Individualized Help measure which now includes the high schools;
- The schools and centres will be provided with the summary of allocations, grants and measures so that they can consult with their respective Governing Boards on how the funds are to be distributed;
- Materials for schools with a pre-kindergarten will be allocated once the school board knows how many pre-kindergarten classes will be opening.

Recommendations of the Resource Allocation Committee WHEREAS the Council of Commissioners of the Sir Wilfrid Laurier School Board adopted resolution #CC-170628-CA-0109, establishing a Resource Allocation Committee to oversee the annual process of budget planning, in accordance with section 193.2 of the Education Act;

6.1.2 2018-2019 Initial Budget:

The Director of Financial Resources noted that the major portions of the initial 2018-2019 budget were presented last evening at a special meeting of the Corporate Committee and went on to highlight the following:

- The budget summary is projecting a balanced budget of 169 885 464\$
- The harmonizing of the tax rate, with the adoption of Law166, is a very positive step;
- The challenges of declining enrolment;
- There is an increase in the decentralization of measures to the schools. A list of priorities is included in the meeting package;
- The teacher allocation is projecting 822 teacher posts down from 828 in the 2017-2018 school year;
- The measure for EHDAA is being calculated in a manner different from previous years;
- The Plan numérique will increase techno pedagogical resources in the schools;
- Expenses by activity:
 - Educational activities and support more funding so there will be more support to students;
 - Administrative costs;
 - Buildings and maintenance there will be a decrease in rentals as the Carpentry Program is now housed at Centre Construct-Plus in St-Eustache;
 - Investments increase in information technology equipment and infrastructure
- The budget will meet objectives and provide support to students with special needs;
- Next steps:
 - Finalize the 2017-2018 school year for the auditors;
 - 2018-2019 budget review the assumptions, review budget by department, review measure funding with the principals to ensure that the rules are being followed, and revise the budget.

In response to an observation by Commissioner Guy Gagnon, the Chairperson requested that the approval of the tax rates for 2018-2019 be on the agenda for the Special Council meeting in early July. A vote is needed to approve the tax rate for the next two years until the Comité de gestion de taxe for the region is established.

WHEREAS the Student Ombudsman concludes that the process used to resolve the complaint, as well as the decision, was fair and impartial;

WHEREAS the Student Ombudsman is not recommending any changes to the school board decision regarding this complaint;

- There are many options available to students once they leave high school and while some may choose to attend CÉGEP, others may select to attend Adult Education and Vocational Training, attend school out of the province or enter the job market;
- Not sure that students can be tracked once they leave high school but they could be asked, on a volunteer basis prior to leaving high school, what their post-secondary plans might be;
- CEGEPs may not be willing to share this information;
- CEGEP teachers do not receive any type of data on students as to previous academic achievement;
- This will be brought to a meeting of the Pedagogical Committee for further discussion.

The Chairperson thanked all members for all of the time and effort given to the Council and wished everyone a safe and happy summer.
