4.0 Reports from the Chairperson and the Director General

4.1 Chairperson's Report:

The Chairperson presented her monthly report noting:

- The CRC Robotics Competition hosted by Laval Senior Academy. The theme this year
 was football and it was very interesting to see how the high school and CÉGEP students
 from across the province constructed the robot to throw a football;
- The Québec consultation on Vocational Training on how to improve what is being offered
 in order to meet the needs of the students and on how to improve the image of the service
 so that it is portrayed as a viable alternative for post-secondary education;
- The Quebec English School Boards Association (QESBA) is lobbying the Ministère de l'Éducation et du l'Enseignement supérieur (MEES) to recognize the English community as a separate sector so that there will be more funding opportunities available;
- The QESBA presented to the Education Parliamentary Commission on Bill 166: An Act to reform the school tax system. This presentation provided the opportunity for the MEES to listen and understand the position of the seven English school boards with respect to management and control of school taxation;
- The QESBA met with the Canadian Heritage Minister to discuss the court challenges program with respect to English school boards;
- The RLPRE (Regroupement Lavallois Pour La Réussite Éducative)launched its « Hooked on School Days » campaign for 2018 from Laval Junior Academy on February 8, 2018;
- The many school events attended.

4.2 Director General's Report:

The Assistant Director General updated the Council of various priorities of Director General's office:

- Attended The Learning Partnership's "Canada's Outstanding Principals Awards 2018" gala in Toronto, as Alan Simoneau, Principal of Lake of Two Mountains High School, was one of three Québec Principals honored at the event. Last year's honoree, Mary Lazaris, Principal of Hillcrest Academy, was also in attendance;
- There is a preoccupation in Canada with respect to equity for ethnic groups and inclusion for people with special needs;
- The Sir Wilfrid Laurier School Board has surpassed its graduation rate of 85%. In the 2015-2016 school year 82.8% was achieved and 85.9% for 2016-2017. Congratulations to everyone involved in the education of the students of this school board for all of their efforts.

In response to a comment from Commissioner Paolo Galati, the Chairperson noted that all schools honour Anti Bullying Day / Pink Shirt Day every February and that it is a wonderful initiative.

WHEREAS the case of "Student A" has been reviewed by the Director General and the parents of "Student A" were informed on 2017-08-18 via e-mail that the administrative decision to decline a request for change in bus stop for the transportation service;

WHEREAS the Appeals Review Committee (the Committee) of the Sir Wilfrid Laurier School Board met on 2018-01-30 to examine the request of the parent of "Student A" to have a revision of the transportation services that were offered to "Student A" at the SWLSB;

WHEREAS the parent was invited to the meeting of the Committee to present the position of the family vis-à-vis the initial request for a modification in bus stop;

WHEREAS the Committee considered the request of the parent said modification for transportation and analyzed all pertinent information;

WHEREAS the challenges presented by the parent supporting the requests refer to issues which do not fall under the responsibility of the SWLSB;

WHEREAS the Committee noted that the current location of the bus stop respect policy no 1999-TS-01: Transportation Policy and Procedures Manual;

Commissioner Guy Gagnon MOVED THAT, on the recommendation of the Appeals Review Committee, the Council of Commissioners of the Sir Wilfrid Laurier School Board resolves that there be no modification of bus stop for the transportation of "Student A" of the Sir Wilfrid Laurier School Board.

- (2) Centre de formation Expérience-Construction Vocational Centre

WHEREAS the Council of Commissioners of the Commission Scolaire de la Seigneurie-des-Millelles, at its meeting of February 27, 2018, assigned the names of Centre de formation Construc-Plus and Centre de formation Construc-Plus Vocational Centre to the Centre de formation professionnelle CSSMI – CSSWL; Commissioner Guy Gagnon MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board support the decision of the Commission Scolaire de la Seigneurie-des-Mille-lles and assign the names of Centre de formation Construc-Plus and Centre de formation Construc-Plus Vocational Centre to the building located at 246, Allée du Golf, Saint-Eustache (Québec);

- Graduation and qualification The MEES requires that all school boards have a graduation rate of 85% by 2030. This school board has already surpassed this rate and will continue to work towards increasing it further;
- Equity The school board needs to reduce the gap in success rates between the various groups of students by 50%;
- Prevention Increase the number of children who do not present a vulnerability factor related to their development by 2025 to 80%. The Ministère de la Famille is heavily implicated in achieving this orientation as the financial gap needs to be closed in order for everyone to have the same access to services;
- Language Proficiency:
 - Increase the success rate to 90% on the composition component of the Elementary 4 language of instruction ministerial examinations in the public system, by 2030. The school board needs to make sure that the MEES understands that this means both English and French for the English school boards:
 - Increase by 5%, the proportion of the adult population of Québec, who demonstrate high-level literacy skills according to the 2011 Program for the International Assessment of Adult Competencies;
- Educational Path Reduce the proportion of students starting public secondary school at age 13 or older to 10% by 2030;
- Living Environment By 2030, ensure that all school buildings are in good condition.

The Council has taken the first steps to move ahead and has suggested the addition of digital citizenship, health and wellness, safety. high quality and effective teachers, Communications, Programming & Curriculum, Fiscal Management, Community Involvement and Partnerships to the list of objectives.

The Chairperson recommended that a Town Hall meeting be held in Laval and at the administrative centre. The Town Hall at the administrative centre would be accessible via videoconference from Joliette and Laurentian Regional High Schools and Ste-Agathe Academy.

7.2 Franklin Hill ES Community Conversation:

The Chairperson advised that there would be a consultation of the Franklin Hill Elementary School community on March 20, 2018 at the school concerning the vocation of the school and how the school board can support the needs of this educational community. A consultation was conducted three years ago on the offerings of the school with the enlargement but it was felt that perhaps it would be in the best interest of the school board to revisit the community to see if the needs continue to be the same.

7.3 SWL Foundation

Commissioner Ailsa Pehi provided an update on the activities of the Foundation noting the following:

The final numbers have been tallied from the January Gala and \$36,000 was raised. Thank
you to all who attended;

- The Foundation is seeking feedback on the gala from those in attendance therefore, a survey has been sent to those the Foundation has contact information. The survey questions ranged from the venue, if the guests have any knowledge of how the funds raised are used, the mission of the Foundation, etc. An update on the results of the survey will be provided when available;
- The Laval Rockets hockey night fundraiser with the Foundation raised \$5,400;
- Auditions for the Starfest portion of the Laurier Gala will be held on April 19 and 21, 2018.
 All of the information concerning this event has been distributed to the schools.

7.4 Parent Commissioners Report:

Parent Commissioner Bob Pellerin noted that the meeting focused on the consultations received on the amendments to the Field Trip Policy and its procedures and the Use of Information & Communications Technology Resources Policy. The members of the Parents Committee has no issues with the technology policy but had some concerns about the tip money section in the procedures for field trips.

The Chairperson congratulated Joliette High School on its first "Kindness, Community & Compassion Breakfast", which was very well received by the community.

Commissioner Melissa Wall left the meeting.
