0.0 Acknowledgement of the Land:

2.1 Process, Timeline and Criteria for the Nomination of a Commissioner for Electoral Division 5:

In response to a question from Commissioner Guy Gagnon, the Interim Director of Corporate Affairs and Secretary General advised that the timeframe for persons to submit their candidatures is more than five days.

Process, Timeline and Criteria for the Nomination of a Commissioner for Electoral Division 5 WHEREAS Dean Dugas, Vice-Chairperson of the Sir Wilfrid Laurier School Board has tendered his resignation as Commissioner for Electoral Division 5, effective November 6, 2018;

WHEREAS the vacant position of Commissioner for Electoral Division 5 must be filled within 30 days in accordance with section 199 of the Act Respecting School Elections;

WHEREAS section 3 of *An Act to defer the next general school election and to allow the Government to provide for the use of a remote voting method* provides for the Council of Commissioners to fill vacancies as per section 199 of the *Act respecting school elections;*

WHEREAS section 199 of the Act Respecting School Elections requires that a consultation with the Parents Committee take place on the criteria for the position of Commissioner;

WHEREAS the Parents Committee was consulted to provide comments and/or recommendations on the criteria for any vacant seats on October 4, 2018, and feedback was received and shared with the Council of Commissioners;

WHEREAS a new commissioner of electoral division 5 must be appointed no later than December 5, 2018;

Commissioner Anne McMullon MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the proposed process, timeline and criteria for the replacement of Commissioner seat on Council, as follows below:

WHEREAS the Commissioner of Electoral Division 5 resigned on November 6, 2018 thus creating a vacant seat for this Electoral Division;

WHEREAS the vacant position of a Commissioner must be filled within 30 days in accordance with section 199 of the Act Respecting School Elections;

WHEREAS section 3 of *An Act to defer the next general school election and to allow the Government to provide for the use of a remote voting method* provides for the Council of Commissioners to fill vacancies as per section 199 of the *Act respecting school elections;*

WHEREAS the Parents Committee was consulted to provide comments and/or recommendations on the criteria for any vacant seats on October 4, 2018, and feedback was received and shared with the Council of Commissioners;

WHEREAS a public notice for the call for nominations will be posted in the school and centres, Website and Facebook page of the Sir Wilfrid Laurier School Board on November 9, 2018, with responses of interested candidates sent to the Interim Director of Corporate Affairs and Secretary General by noon on November 16, 2018.

WHEREAS candidates for the vacant seat will be presenting to the Council of Commissioners and Parent Committee members on November 21, 2018 at 6:30 p.m.;

Commissioner Guy Gagnon MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board call for nominations for the vacant seat in Electoral Division 5.

WHEREAS given the recent changes to the membership of the Council of Commissioners of the Sir Wilfrid Laurier School Board, it will have to name new representatives;

Commissioner Vicky Kaliotzakis MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board name **Paolo Galati** to the Board of Directors and Executive Committee of the Quebec English School Boards Association (QESBA) for the balance of the 2017-2019 mandate.
