Commissioner James Di Sano MOVED THAT, on the recommendation of the Director of Material Resources and Transportation, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the change order credit in the amount of 2 137,74\$ net taxes;

AND THAT the total cost of the project, including the change orders, be increased to 2 086 287,09\$ net taxes;

AND THAT, the Chair, as well as the Director General, and in her absence or with her knowledge the Assistant Director General, be authorized to sign all documentation concerning this project.

7.3.3 Tender Validity Extension – Construction Projects:

The Director of Material Resources and Transportation advised that the tender validity extension would provide some leeway with the verification of plans and specifications by a city or town, any changes they might request that may be required prior to the issuance of permits.

Tender Validity Extension Construction Projects

CC-190123-MR-0124

WHEREAS, as per Article 39 of the Regulation respecting construction contracts of public bodies, states that an "Authorization from the chief executive officer of the public body is required before a notice of the call for tenders is published if the tender validity period is greater than 45 days" and, in the case of a school board, the chief executive officer is the Council;

WHEREAS the implementation of the Autorité des Marchés Publics (AMP) a Contractor is now allowed to make a complaint during the tendering process and, if this is the case, the school board may have to lengthen the tendering process from a minimum of 15 days to approximately 25 days;

WHEREAS a consequence of the lengthening of the tendering process and potential complaints could result in additional delays being added to the 25 days previously mentioned;

WHEREAS the approval of the results of a tender are time sensitive and there is always the possibility of encountering a situation where a regular meeting of the Council is not scheduled within the required timeframe for approval;

WHEREAS it is preferred that the school board have the permit in hand prior to awarding the tender to a general contractor so as to ensure that there are no unforeseen demands from a city, which is a process that is often delayed for various reasons;

WHEREAS obtaining a permit often places the school board in a situation where a city will not issue a permit until the general contractor has been awarded the contract;

WHEREAS it would be advantageous for the Director of Material Resources and Transportation to be able to increase the tender validity period from 45 days up to but not exceeding 90 days without having to bring a request to the Council every time an increase is required;

Commissioner Melissa Wall MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board authorize the Director of Material Resources and Transportation to extend the tender validity period from 45 days up to but not exceeding 90 days for all calls for tenders for the services of a general contractor;

AND THAT this resolution is in effect until replaced.

8.2.2 SEAC Report:

Parent Commissioner Stéphane Henley presented and reviewed the monthly SEAC Report noting:

- The next conference is February 19, 2019 and will deal with work and life balance. People can participate in person or online;
- The conference in April will deal with Speech Therapy and the one in May will be on Occupational Therapy;
- SEAC is trying to have as many conferences as possible in order to generate visibility;
- SEAC now has a Facebook page;
- The overcrowding situation at Crestview Elementary School is causing concern for the committee;
- A marketing plan for SEAC is being worked on.

8.3 Report of QESBA

Commissioner Peter MacLaurin advised that the next meeting of QESBA is Friday, January 25, 2019. At this meeting, a new Vice-Chair will be elected to replace Jim Shea of the Western Quebec School Board.

9.0 Question Period:

The Interim Director of Corporate Affairs and Secretary General explained the process for question period.

In response to questions from Commissioner Guy Gagnon, the Director of Material Resources and Transportation, with the assistance of the Director General, noted the following

- Two directives have been received from the MEES to ensure that all schools are equipped with carbon monoxide detectors;
- The school board has carbon monoxide detectors in all the schools that have a combustion furnace;
- There are also detectors for methane gas;
- The detectors are calibrated every two years and are connected to the alarm system of the school board;
- The schools received a procedure for the detectors in January 2018;
- At 30 parts per million the detector alarm goes off for the first time and there is a second alarm at 200 parts per million;

- CNESST allows for 15 minutes of exposure but the school board will immediately call 911 and evacuate the school;
- To date the school board has never had this type of alarm go off;
- If contractors do not report carbon monoxide alarms this is cause for dismissal and the school board moves to the next lowest conformable bidder on a project;
- The request from the MEES was responded to and the school board procedure was sent
 with the response. The MEES has since contacted the school board to ask permission to
 use this procedure for all school boards in Québec;
- The school board has authorized the schools to forward the procedure to parents who have made inquiries.

In response to question from Commissioner Peter MacLaurin, the Chairman noted that the topic of seat belts on school buses will be brought for discussion at the Corporate Committee and then, if necessary, a recommendation can be made to Council.

Commissioner Emilio Migliozzi noted that by 2020 all new school buses would be equipped with seat belts.

Stephanie McLellan, President of the Laurier Teachers Union (LTU), advised the Council that LTU has received very positive feedback from its members who have taken part in "Coffee & Conversation with the DG". Those who have been able to attend appreciated the fact that the event was informative, relaxed and enjoyable.
