5.0 Question Period

The Interim Director of Corporate Affairs and Secretary General reviewed the process for asking questions during question period.

The Chairman thanked Theresa Andrusko, a concerned parent from Genesis Elementary School, for all of her questions. He noted that after discussions with the Council, the school board would like to offer the community a Town Hall meeting to listen to all of the questions and concerns from the Laval community on wanting other options for high school besides Laval Junior and Laval Senior Academies. The Town Hall would be held at Laval Senior Academy in the auditorium on a date and time to be determined with the community.

Ms. Andrusko and other members of her group agreed to holding a Town Hall noting that the group wants to have transportation points in Laval that would enable students to attend Rosemere High School because it would provide another option for high school to the students in Laval. If this option was supported, students would remain in this school board rather requesting to go to school in Montréal. Rosemere High School is not at capacity and could house students from Laval with transportation.

The Chairman advised that the school board has submitted a request to the Ministère de l'Éducation et de l'Enseignement supérieur (MEES) for a special project school, also known as a 240 school, and is currently waiting for a response. The 240 school is planned for the 2019-2020 school year and will be a STEM (Science, Technology, Engineering and Mathematics).

He went on to note that the school board transportation policy states that if your child goes to school outside of the assigned school zone, transportation is the responsibility of the parents.

On a "point of order", Commissioner Guy Gagnon noted that this is an important conversation but that a proposal is on the floor for a Town Hall meeting where this issue will be discussed and asked that the discussion be brought back on track.

The school board will contact Ms. Andrusko to organize a date suitable to everyone.

In response to questions from Melanie Massarelli, Laurier Teachers Union Representative for Lanaudière Rive-Nord Secondary, the Chairman answered as follows:

- There have been five different versions of the 2018-2019 budgetary rules which has resulted in many challenges as each time an amended version was received that the school board was obligated to adjust its budget accordingly;
- The MEES often distributes measure monies late in the school year, around the end of April, which makes it difficult to spend the entire amount prior to June 30;
- The 2017-2018 school year introduced the new measures structure and now mechanisms have been put in place for the 2018-2019 school year that will provide more detailed follow-up on the measure monies that are to be spent prior to June 30.

6.0 Report from the Chairman

The Chairman provided an overview of events he has attended since being named to his position and thanked all of the Commissioners who were available to accompany him to these events. He also thanked Daniel Johnson, Pedagogical Services Project Development Officer, for all of his work with the students at several of these events.

WHEREAS, the Executive Committee of the Sir Wilfrid Laurier School Board adopted resolution #EC-180926-MR-0010 approving the change orders related to various structural and plumbing modifications in the amount of 60 544,88\$, before taxes (69 611,48 \$, taxes included) increasing the total cost of the project to 1 583 004,88\$, before taxes (1 820 059,86\$, taxes included);

WHEREAS, during the renovation project additional change orders occurred relating to soil decontamination and the removal of contaminated materials in the amount of 110 591,12\$, before taxes (127 152,14\$, taxes included);

Commissioner Anick Brunet MOVED THAT, on the recommendation of the Director of Material Resources and Transportation, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the change orders in the amount of 110 591,12\$, before taxes (127 152,14\$, taxes included);

10.1 SWL Foundation:

Commissioner Anick Brunet, in her capacity as a public member of the Sir Wilfrid Laurier Foundation (the Foundation), noted the following:

- The allocation of funds to the schools for multi-sensory equipment.

- October 4, 2018 This was the first meeting of the 2018-2019 school year and the Parents Committee executive and representatives to various committees for the year were elected;
- November 1, 2018 Discussions took place on the consultation on the Policy on Tobacco, Alcohol and Drugs, RCP-3L representatives, best practices and the Parents Committee Facebook page. SEAC members were named for 2018-2019.

In response to questions concerning the Sir Wilfrid Laurier Foundation (the Foundation), the Chairman noted:

- The Foundation does have by-laws that may include its process for naming people to the Board of Directors;
- The Foundation has postponed the nomination of any new members until the new year;

On a "point of order", Commissioner Vicky Kaliotzakis noted that the Commissioner in question on the Foundation was originally named as a member of the business community and not in the capacity of a Commissioner.

10.3 QESBA

The Chairman reported that he had attended his first meeting of the Quebec English School Boards Association (QESBA) noting:

- The introduction of the new QESBA Executive Director, Russell Copeman, and its new President, Dan Lamoureux;
- Discussions on the election of the Coalition Avenir Québec (CAQ) and that school boards will need a united front once the CAQ begins to lay the groundwork to abolish school boards. School boards have been abolished in Nova Scotia, Prince Edward Island and Saskatchewan but minority school boards were left untouched as they are protected under a federal charter, as is this school board;
- The upcoming Annual General Meeting on December 1, 2018;
- Plans of the Chairman and Executive Director of QESBA to visit each member board.

11.0 Oath of Office

11.1 Commissioner Electoral Division 5:

The Director General received the Oath of Office of the Commissioner for electoral division 5, Bob Pellerin, and welcomed him to the Sir Wilfrid Laurier School Board.

Commissioner Pellerin thanked the Council for its vote of confidence noting that he will work hard to keep stakeholders informed of the undertakings of the school board.

12.0 Question Period:

In response to a question from Stephanie McLellan, President of the Laurier Teachers Union, the Chairman noted that the Town Hall meeting concerning Laval students attending high school in Rosemère would be open to everyone.

In response to questions from Renata Isopo, Journalist for The Laval News, the Chairman, with the assistance of Commissioner Peter MacLaurin, noted:

- There has been no increase in the membership fees of QESBA for 2018-2019, it continues to be a flat rate of \$8.33 per student;
- The payments to QESBA are in instalments with 75% being paid in June and the remaining 25% in October or November annually;
- The most importance piece of being a member of the QESBA is that it lobbies for the rights of the English education community at the level of the government;
- The money is used to look after the best interests of the English school boards and its students.
