## 5. QUESTION PERIOD FROM THE PUBLIC

## 6. NEW BUSINESS

- The committee agreed on sending a resolution concerning the strike actions, as opposed to writing a letter.
- Laval Junior Academy questioned is if was the PC place to send a resolution. He went on to say that he supports the Council of Commissioners resolution.
- The chairperson responded that as parents we do have a right. Although we do support the employees in their strikes, we want to
  encourage the government to move forward with the negotiations.
- Should the PC be sending a message to the board that they are not managing it well. It is hard for a kindergarten student to do online learning for that amount of time. The chairperson responded that this is a secondary issue and this resolution is directed to the government. The delegate sees the value of preparing one for the school board to perhaps better manage how the students learn during these strike days.
- Members agree on sending a resolution as it is parents who are having to live through this, taking time off work in order to be able to stay home with their children during these strike days.
- Pinewood Elementary finds that the number of hours of online learning that is happening during the strike days does not reflect what happened a year ago. There is disparity with the hours given a year ago as to what is being given during these strike days.
- SEAC would like to emphasize stronger the disappointment in the process and how long the negotiations are taking to conclude.
- Franklin Hill Elementary feels that if a student does not attend the zoom class on strike days but gets the homework done, they should not be marked as absent. The chairperson acknowledged that each school is responsible to manage the way their online learning is conducted during strike days.

#### 6.1 Ongoing strike actions

WHEREAS in recent months there have been numerous strike actions from the various unions that represent the different categories of school staff including teachers, support staff, day care staff, care takers and numerous other areas;

WHEREAS these numerous strike actions have brought academic concerns from parents, as well as childcare challenges;

WHEREAS due to the ongoing Covid-19 pandemic parents feel general frustration towards the additional lost hours and days of classroom learning for their children;

WHEREAS our Parents' Committee feels the urgency to advocate for our children;

WHEREAS the Parents' Committee of the Sir Wilfrid Laurier (SWL) school board fully support all our staff and their respective unions;

WHEREAS the Parents' Committee recognizes that all our staff regularly go above and beyond to support our children on their academic journey;

WHEREAS the Parents' Committee exists to represent the voice of all parents within our community;

WHEREAS the SWL Parents' Committee is aware of a similar resolution passed by the SWL Council of Commissioners and supports the existing resolution speaking for all stakeholders;

WHEREAS the SWL Parents' Committee would like to re-enforce the importance of all unions being able to quickly reach amicable agreements;

PC2021052-02 Joliette High MOVED THAT the Sir Wilfrid Laurier Parents' Committee firmly requests that the Quebec Government find common ground with all the provincial unions in order to conclude negotiations so that new contracts can be signed in a timely manner;

AND THAT a copy of this resolution be shared with the Ministère de l'Éducation, the Chairman of the SWL Council of Commissioner, the Director General of SWLSB, the English Parents' Committee Association, the Quebec English School Board Association, all English school board Parents' Committee Chairs, as well the leaders of all local unions of the SWL employees. Seconded by St. Vincent Elementary.
