5.0 Report from the Chairperson

The Chairperson declared that he is very proud that COVID-19 has not stopped the Sir Wilfrid Laurier School Board. He thanked all employees and parents for their patience and for reinforcing the health protocols with their students and/or children. Everyone has and is doing an excellent job of working together to keep everyone safe.

He continued, presenting his monthly report and noting:

- A generous donation from Guy Ouellette, Member of the National Assembly for Chomedey, to John F. Kennedy, Our Lady of Peace and Souvenir Elementary Schools of science boxes, which contain science experiments for cycles 2 and 3 students;
- On the evening of May 28, 2021, the Laurier Gala and Hopefest will take place at 7:30 p.m. on Facebook Live. There were 75 video submissions so it made it incredibly hard to select 16 acts to perform. Over 200 students will be honored at this event for achievements in academics, arts, sports, citizenship and school perseverance.

On a sad note, the Chairperson informed the Council and audience of the passing of Elisabeth Rossi, Administrative Technician at Pedagogical Services. Ms. Rossi was a long-time employee of the school board and will be missed. He expressed condolences to Ms. Rossi's husband and her daughters and their families.

A moment of silence was held in remembrance of Elisabeth.

6.0 Report from the Director General

The Director General presented her monthly report noting:

- <u>Strike Actions</u>
 - The CSN is the next union to strike and the strike began at noon today and will end at noon tomorrow;
 - The next strike action will be taken by the Professionals on June 9, 2021, from 0:01 until noon;
 - The right of the unions to strike must be respected;
 - While the school board will always prioritize in-person learning, it needs to consider the safety and security of all stakeholders and the need to maximize instructional time;
 - The school board's Mission & Vision statement says that The Sir Wilfrid Laurier School Board believes that all students deserve our complete commitment to their success;

- All students, employees, parents and stakeholders are thanked for being patient during these unprecedented times;
- It is hoped that the government and the unions can soon find common ground;
- Vaccination Partnerships
 - The school board has entered into partnerships with the Centre intégré de santé et de services sociaux (the "CISSS") in the regions of Laval, Laurentides and Lanaudière for the vaccination of students over twelve years of age. The vaccination period is from June 7-14, 2021, but the dates and procedures for each region have not yet been determined;
 - The procedures will be somewhat different by regions;
 - There will be a hybrid model for the vaccination process with some high school students receiving their vaccination at school, while others will be transported from the school to the closest vaccination centre. Grade 6 students will also be transported either to the closed high school or vaccination centre;
 - Since May 25, 2021, parents have been able to make appointments to have their children vaccinated who are over tweleve years of age, through Clic Santé. Students who have already received their vaccine will not have to be a part of this program;
 - Special thank you to the Communications Team for their assistance in distributing this information quickly;
- Proud Moments
 - May 20, 2021 Attended Coding at RHS with WOTP Students which showcased the achievements of the WOTP (Work Oriented Training Path) students who did the coding and designed their own game. Some of the year 3 WOTP students were looking for a stage and found one with KidCoders Computers Academy (KCA) and they brought what they learned back to the school;
 - May 21, 2021 Attended the launch of the Campaign: Awareness and Prevention of Domestic Violence in Argenteuil. This campaign is supported by many partners to raise awareness about domestic violence, especially given the ongoing pandemic. The campaign will see signs distributed throughout the nine municipalities of the MRC d'Argenteuil displaying messages about the prevention of domestic violence. Services for the prevention and victim assistance related to domestic violence will be offered in English. Special thanks to Mélanie Bujold, CLC Coordinator at LRHS;

8.2 Information Technology

8.2.1 Microsoft Licences

The Director of Information Technology noted that the tender for the Microsoft licences were called on February 10, 2021, and on April 7, 2021, the government issued a decree that allows the Centre d'acquisitions gouvernementales (CAG) to enter into contracts with numerous suppliers. The Council approved the payment of the invoice to be received for the 2021-2022 Microsoft Corporation licence fees and the purchase order was processed. On May 25, 2021, the school board was advised by the CAG that an additional resolution would be required, which is being presented this evening.

WHEREAS on May 25, 2021, the Sir Wilfrid Laurier School Board received information from the Centre d'acquisitions gouvernementales (CAG) concerning a change in strategy with regard to the contract to be awarded for the acquisition of Microsoft licences;

WHEREAS said contract will be awarded to the licence reseller Softchoice by mutual agreement for a period of thirty-six (36) months;

Commissioner Bob Pellerin MOVED THAT, on the recommendation of the Director of Information Technology, the Council of Commissioners authorize the Director General to confirm to the Centre d'acquisitions gouvernementales the participation of the Sir Wilfrid Laurier School Board to the contract to be awarded to the licence reseller Softchoice by mutual agreement, as per document no. 10.0 Question Period

In response to a question from Jason Stewart, a member of the online audience, the Director General noted that a strike day is like a puzzle, many pieces need to fit together properly, so the following is taken into consideration when planning for a strike day and when making the decision to hold classes online rather than in-person:

- A plan or criteria is established for each strike day;
- The safety and security of everyone;
- The right of all unions to strike is to be respected;
- Prioritizing in-person classes whenever possible;
- Transportation:
 - The school board transports 93% of its student population so there is always high density traffic around the schools because of buses and parental drop-off and pickup;
 - The coordination with regard to the transportation of students who are a part of a transportation wave;

 There are students who would spend more time being transported than being in class if in-person classes were sanctioned during the school hours that are not a part of the strike hours.

The Chairperson also commented that transportation is a complex issue given that the school board territory covers 35,000 sq/km and the fact that there are two interboard transportation agreements.

In response to a question from Marie Boivin, a member of the online audience, the Director General noted that there is no ideal solution for situations where in-person classes are not possible and, like students from Grade one through Grade eleven, the school board needs to ensure that regular timetable of the pre-kindergarten and kindergarten students is respected. The school board acknowledges that there has been a loss of instructional time so all efforts are being taken to maximize said time.

The Chairperson commented that COVID-19 has created an unprecedented time and while the school board does prioritize in-person classes there are times that it is not possible. Things are looking up as the government continues to negotiate with the unions and as it also implements its plans for reopening.
