4.1.3 Creation of Positions – Professionals

The Director of Human Resources noted that the upcoming resolution is for special projects that, as per the professionals' collective agreement, can be made permanent after three years. The three-year period has concluded and these positions are required.

- The 10% position is under a specific measure and is added with another position to make a regular position;
- Occupational Therapists do evaluations and write reports while consultants go into the classroom to observe, report and recommend;
- In the school system Occupational Therapists do not give group therapy;
- The reference to Laurier Senior High School on the professionals staffing plan will be looked into.

In response to a question from the Chairperson, the Director of Corporate Affairs and Secretary General advised that Commissioners who are not members of the Executive Committee cannot participate in discussions at the table but they can ask questions if the Chair agrees.

4.2 Corporate Affairs and Secretary General

4.2.1 Agreement - Centre de pédiatrie sociale en communauté d'Argenteuil

Commissioner Donna Anber commented that this centre provides much needed services in English that are not available to the student anywhere else.

In response to a question from the Chairman, the Director General noted that the Director of Corporate Affairs and Secretary General has worked with the Principal of Laurentian Regional High School (LRHS) so it has been advertised at the Governing Board.

The Director of Corporate Affairs and Secretary General noted that this is a very positive project for the LRHS community and that this is the second agreement to be brought to the Executive Committee. She also noted that a new director general of the Centre was named. The service is available to all students attending notably LRHS, including those who live outside of Argenteuil. The most vulnerable students are eligible for these services.

In response to a question from Parent Commissioner Adam Gordon, the Director of Corporate Affairs and Secretary General noted that the Vice-Chairperson in the signing clause refers to the Vice-Chairperson of the Executive Committee.

Agreement

WHEREAS the Executive Committee of the Sir Wilfrid Laurier School Board adopted resolution no. EC-200226-CA-0038, entering into a three-year agreement with the Centre de pédiatrie sociale en communauté d'Argenteuil (the "Centre de pédiatrie");

WHEREAS there are certain elements of the current agreement that require precisions as well as certain amendments;

WHEREAS the Sir Wilfrid Laurier School Board and the Centre de pédiatrie have collaborated on the precisions and amendments to the agreement;

WHEREAS the Centre de pédiatrie will continue to lease space at Laurentian Regional High School, as supported by the Governing Board of Laurentian Regional High School;

WHEREAS this agreement will be for a period of three (3) years:

Commissioner James Di Sano MOVED THAT, on the recommendation of the Director of Corporate Affairs and Secretary General, the Executive Committee of the Sir Wilfrid Laurier School Board enter into a three-year agreement with the Centre de pédiatrie sociale en communauté d'Argenteuil;

AND THAT the Chairperson or, in their absence or with their knowledge, the Vice-Chairperson as well as the Director General or, in their absence or with their knowledge, the Assistant Director General be authorized to sign all documentation concerning this agreement;

FURTHER THAT this new agreement replace the agreement adopted by resolution no. EC-200226-CA-0038.

4.3 **Pedagogical Services**

4.3.1 Entente with the CISSS des Laurentides – Regional Mental Health Support Project

The Director of Pedagogical Services noted that this entente establishes the parameters for the funding to be received that will enable the school board to have two days of service per week in the Laurentians.

In response to a comment from Parent Commissioner Adam Gordon, the Director of Corporate Affairs and Secretary General advised that this entente is a draft and that his comment is noted and the authorized signature for the school board will be corrected in the final version of the entente.

Laurentides - Regional Mental Health Support **Project**

Entente with the CISSS des WHEREAS, in the fall of 2020, the Ministère de la Santé et des Services sociaux, in collaboration with the Ministère de l'Éducation, unveiled a regional project to support mental health and better serve students who live with various mental health issues;

WHEREAS the Government will be investing \$30,000,000.00 province-wide for the promotion and prevention of mental health and addiction;

WHEREAS an agreement on the Regional Mental Health Support Project has been negotiated between the Sir Wilfrid Laurier School Board and the Centre intégré de santé et de services sociaux des Laurentides:
