2.0 Recognition - FitBit Initiative at Grenville ES

The Chairperson welcomed Nancy Bennett, Principal of Grenville Elementary School; and her teachers Tracy McTavish and Meghann Wicki, to the meeting noting that these two teachers and their students have been walking all around the world and recently finished a tour of Greece.

The Principal of Grenville Elementary school thanked the Council for the opportunity to present its FitBit initiative as the school is very proud of it. The initiative will take place throughout the year. She also thanked Commissioner Donna Anber, Parent Commissioner Adam Gordon and the Director General for their most recent visit to the school, as the students really enjoyed having them there.

Ms. Wicki thanked the Council for the honour of being recognized and for the opportunity to present this initiative to them as the students are very grateful for being able to do this project. Erika Alarie and Lincoln Hall are also present this evening will share their FitBit initiative experiences.

She went on to note that this initiative was planned over the summer months to address some of the challenges of virtual learning and the thought of bringing travel and fitness into the classroom was an interesting concept. Arrangements were made for each student to be loaned a FitBit device and they now keep track of their steps and follow the health measures provided by the device. They recently completed a 42 kilometer marathon to Athens, Greece, during the first month of school this year. The next projects with the FitBit will involve *Percy Jackson and the Olympians* book series and in the spring they will do one with the classic *Call of the Wild*. The students keep track of all the data in a journal. This initiative would not be successful without the assistance of Ms. MacTavish.

Ms. Alarie and Mr. Hall presented their experiences with the FitBit noting:

- They like tracking their steps and seeing their progression when they add them to their journal;
- The initiative is fun to do as a class and with their friends;
- They love to visit the different cities and they especially liked running through New York City;
- They learn a lot from making a graph of their steps, as they go up and down depending on the day and how many steps were taken, everyone's graph is different.

Ms. MacTavish congratulated Ms. Wicki on coming up with the great initiative and thanked the Principal for her support. The students are excited by the initiative and have commemorated it with T-shirts and enjoy the fact that they can celebrate their successes as they complete each leg of the journey. Part of the initiative is very technical and the students are very good with any of the challenges it presents.

Ms. Alarie and Mr. Hall thanked the Council, their teachers and Principal for allowing them to come this evening.

The Chairperson thanked the students, teachers and Principal of Grenville Elementary School for being present this evening because it is always an honor for the Council to hear about how the students are being engaged in their learning.

4.0 Question Period

The Secretary General and Director of Legal, Corporate and Communications explained the parameters of the question periods and drew attention to where people online can type in their questions for the second question period.

She further confirmed that there were no questions received for the first question period and that the second question period is for questions related to agenda items only.

5.0 Report from the Chairperson

The Chairperson thanked everyone for attending this evening noting that it has been a year of challenges beyond our control and that, with the help of the stakeholders, the school board has been able to reach goals and make each day better for its students, all while keeping everyone safe. COVID-19 and its new variant has increased the challenge of keeping everyone safe but the school board continues to adhere to all public health protocols with the cooperation of parents and employees. Everyone is to be thanked for working to keep the COVID-19 numbers low, students for listening and following the rules, parents for being great partners, administrators and teachers for adapting to the ever-changing demands, and caretakers for ensuring that the public health sanitary protocols are followed.

He wished everyone a very happy and well-deserved holiday break.

He presented his monthly report noting:

- December 14, 2021 Attended a Quebec English School Boards Association Executive Committee meeting where Bill 9: An Act respecting the National Student Ombudsman was discussed. A brief will be drafted for presentation;
- The second annual Embracing Diversity Conference will be held on January 18, 2022, for Sir Wilfrid Laurier School Board families and it is a free event;
- At the 2021 Laurentian Regional High School (LRHS) Remembrance Day ceremony Indigenous veterans were honored through a video that was written and produced by a former LRHS student, Rowen Draper, and narrated by Ethan Picard a current student at LRHS. The video was shown for the Council.

Community Comments from Commissioners

- Commissioner Melissa Wall noted that on December 1, 2021, she attended the Santa Bus event at Mountainview Elementary School whereby Santa arrived by bus and each class had the opportunity to see their arrival and view a short show. She also informed the Council that Ms. Mann's grade six class at St-Jude Elementary School participated in a Christmas card contest put on by the Régie de Police du Lac des Deux-Montagnes and that one of the students had their drawing selected for the card. Three members of the Police went to the school to surprise the student with their win. The student and their family received an invitation to visit the station for a tour;
- The Chairperson noted that Communications has been using student images in the school board's marketing and that it would be a good idea to approach the Principals about also using student artwork for this purpose;
- Commissioner Vincent Cammisano congratulated everyone at Souvenir Elementary School, Laval Junior Academy and others who collected and donated food to AGAPE, as their generosity is very much appreciated.

6.0 Report from the Director General

The Director General welcomed everyone to the meeting. She introduced Ms. Daphne Di Marco and Ms. Sofia Mansour, grade five students at John F. Kennedy Elementary School (JFK), who will be helping her present her monthly report this evening.

Ms. Di Marco and Ms. Mansour explained how they are being engaged at school through listening to the Student Voice, daily circles, the buddy program, the leadership program, and the Game Changers group that help others. They also noted that they received the honor of being Principal for a day with their Principal, Ms. Marchitello. During their day as Principal they were able to greet the students as they came to school, performed recess and lunch duty and attended a restorative circle to help students. They also had the opportunity to meet and interview the Director General of the Sir Wilfrid Laurier School Board about her job. They also toured the school to point out areas that would eventually require improvements. The Director General also had questions for them about the school to which they advised that it is a school that is joyful, respectful and kind.

The Director General noted that the upcoming video of the students at JFK is a testament that they are engaged.

The video was viewed.

Ms. Di Marco and Ms. Mansour highlighted the CTPS Orientation 5: *Engage students in physical activities for 60 minutes a day* noting the Souvenir Elementary School staff VS students basketball game on November 30, 2021, and the head office initiative *Bouger = Santé with Marcelin Cantin*, which took place for fifteen minutes once a week for ten weeks with the head office staff.

The Director General noted that for CTPS Orientation 3: Develop a learning and working environment that promotes health, safety and well-being, the school board partners with the health sector, especially during this pandemic and asked the Coordinator of Communications, as a member of the SWLSB Covid Team, to give more details about the vaccinations campaigns.

The Coordinator of Communications advised that the vaccine campaign for students aged 5-11 is underway in the Laval, Laurentides and Lanaudière regions until December 21, 2021. Parents have received the information for their region on how the vaccination will work. The MEQ has announced that every student will receive a box of 5 rapid tests to have at home to use if they have COVID-19 symptoms. Before the holiday break, these tests will be distributed.

The report of the Director General continued with Ms. Di Marco and Ms. Mansour highlighting CTPS Objective 5: Ensure that the infrastructure is conducive to 21st century learning and working, noting that Laval Senior Academy has recently added door decals on the front door of the school to promote its diversity and school programs. LSA has also recently undergone major renovations to its auditorium.

The Director General reminded everyone of the following upcoming opportunities:

- Embracing Diversity Conference on January 18, 2022, which is open to all parents;
- Laval Senior Academy will be hosting the 2022 edition of the Montréal Regional Science & Technology Fair from March 27-29, 2022. This is a true partnership with the schools and departments to make this event successful. A special thank you to Heather Mcpherson, Science teacher at the school, for all of her involvement and contribution towards organizing and hosting the fair.

She went on to thank Ms. Di Marco and Ms. Mansour for assisting with her report, wished them a Happy Holiday and told them to check their school mailbox for something special. She also commended the leadership skills of the Principal of JFK, Ms. Tania Marchitello, for being a great leader.

The Principal of JFK thanked the Director General for her kind words and wished everyone the best of the season.

The Chairperson noted that he is always inspired by the students who come to Council. He thanked the students and the Principal of JFK, on behalf of the Council and to have a nice relaxing holiday break.

- For the current school year, the school board billed for almost \$6,5000,000.00, in school taxes of which, at this time, \$903,175.55, has not been collected or 13.89 percent;
- The unpaid school taxes must be looked at year-by-year because, while the current school
 year indicates that there is 13.89 percent of school taxes that remain outstanding, it must
 be remembered that the unpaid accounts continue to be collected by sending annual
 reminders and that the unpaid balances are only for that specific school year;
- If the bailiff is unsuccessful in the collection process there are other options to be considered for collection. It must be noted that the last resort for the school board for collection would be the seizure of salary.
