4.1.1 Short-Term Borrowing Plan

Short-Term Borrowing Plan

EC-211215-FR-0028

WHEREAS, in accordance with section 78 of the *Financial Administration Act* (CQLR, chapter A-6.001), the Sir Wilfrid Laurier School Board (the "Borrower") wishes to establish a borrowing plan, valid until December 31, 2022, allowing it to obtain loans in the form of a line of credit with the Ministre des Finances, as the person responsible for the Financing Fund, to fund capital projects for which a subsidy has been granted by the Ministre de l'Éducation (the "Projects");

WHEREAS the maximum amount to be borrowed under this plan must not exceed the amounts authorized for these projects by the Ministre de l'Éducation in accordance with the *Education Act* (CQLR, chapter I-13.3) and the *Financial Administration Act*;

WHEREAS funding for these Projects will be obtained exclusively from the Ministre des Finances, as the person responsible for the Financing Fund;

WHEREAS all short-term loans obtained from financial institutions to fund these Projects must, on their maturity date or as soon as possible, be obtained from the Ministre des Finances, as the person responsible for the Financing Fund;

WHEREAS it is deemed appropriate to authorize this borrowing plan and to accept its terms and conditions;

WHEREAS, in accordance with section 83 of the *Financial Administration Act*, the Borrower wishes to provide that, under this borrowing plan, the power to borrow and the power to approve the terms and conditions of the borrowings be exercised by at least two of its officers;

WHEREAS this borrowing plan must be authorized by the Ministre de l'Éducation, in accordance with the Education Act and the Financial Administration Act;

Commissioner James Di Sano MOVED THAT the Executive Committee of the Sir Wilfrid Laurier School Board approve:

- 1. THAT, subject to the required authorization from the Ministre de l'Éducation, the Borrower be authorized to establish a borrowing plan, valid until December 31, 2022, allowing it to obtain loans in the form of a line of credit with the Ministre des Finances, as the person responsible for the Financing Fund, to fund capital projects for which a subsidy has been granted by the Ministre de l'Éducation (the "Projects"), subject to the following characteristics and limits:
 - The interest rate payable on these loans shall be established according to the criteria determined by the Government under Order-in-Council number 432-2018 of March 28, 2018, as such order-in-council may be amended or replaced from time to time;
 - The line-of-credit loans shall be made in accordance with the line-of-credit agreement to be concluded with the Ministre des Finances, as the person responsible for the Financing Fund, and with the established terms and conditions;
 - c) The amount of each line-of-credit loan cannot, at any time, exceed the amount authorized by the Ministre de l'Éducation in accordance with the authorization letters delivered from time to time by the Ministre concerning these projects;

- THAT the Projects be funded exclusively with the Ministre des Finances, as the person responsible for the Financing Fund;
- 3. THAT, for the purpose of determining the amount of the loans referred to under section 1 c), only the balance of current, not yet repaid, loans obtained from the Ministre des Finances, as the person responsible for the Financing Fund, be taken into account as well as the short-term loans obtained prior to this resolution from financial institutions for these Projects;
- 4. THAT all current short-term funding obtained from financial institutions for the purposes of the Projects be, on the date of maturity or as soon as possible, obtained from the Ministre des Finances, as the person responsible for the Financing Fund;
- THAT, for the purpose of acknowledging each loan or each repayment of the principal or the interest on the lines of credit, the Borrower be authorized to deliver to the Ministre des Finances, as the person responsible for the Financing Fund, a confirmation of transaction;
- 6. THAT the Director of Financial Resources and the Director General or the Assistant Director General, provided two of them act jointly, be authorized, on behalf of the Borrower, to sign all confirmations of transaction for the purposes of acknowledging each loan obtained under the terms of the line-of-credit agreement or to make any repayment on these line-of-credit loans;
- 7. THAT the Director of Financial Resources and the Director General or the Assistant Director General, provided two of them act jointly, be authorized, on behalf of the Borrower, to sign the line-of-credit agreement, to agree to any and all additions or amendments not substantially incompatible with the provisions herein and to take all actions and sign all documents, necessary or useful, to give full effect to the line-of-credit agreement;
- 8. AND THAT this resolution replace all resolutions previously adopted for the same purposes.
