WHEREAS the eLearning Initiative will be created and launched by the 2022-2023 school year at a cost of \$85,000.00;

Commissioner Donna Anber MOVED THAT, on the recommendation of the Advisory Committee – Student Success, the Executive Committee of the Sir Wilfrid Laurier School Board approve the partnership with the Pure & Applied Group for the creation of the eLearning Initiative at a cost of \$85,000.00, plus all applicable taxes.
