7. PRESENTATIONS

7.1 Financial Resources

Welcome to Chao Ling Pan, Director of Financial Resources who will present the results of the Budget Building Survey.

The budget building consultation is done on an annual basis and several stakeholders are consulted to answer the survey. 100% of those surveyed participated. The Director presented the global results of the survey to the members and spoke about the next steps. Impact of budget consultation:

- Collect information from the community
- Engage discussion on school board's priorities
- Align priorities with available resources

Annual update to the Allocation to Resource document. Commonly used criteria to allocate resources (not in particular order):

- Weighted enrolment (Student with Code)
- Per capita (head count)
- Buildings per school
- Socio-economic index (IMSE)

Plan of action – Improve budget comprehension in schools and centres

- Yearly workshops for administrators/sharing good practices
- Development of planning tool for decentralized measures
- Monthly financial reports
- Resource allocation committee meetings

Plan of action – Improve budget comprehension on governing boards

- Continuation of the training in the fall and spring
- Present financial reports 3 times annually
- Annual budget consultation
- Provide feedback to GB about results of the consultation and impact on budget planning.
- Improve budget comprehension on where GBs can actually spend their money.

Helping at risk students

- Creation of a focus group composed of PSD, principals and school org.
- Analyze the current situation
- Define needs
- Provide recommendations
- Laurentian Elementary if a student arrives in the middle of the year with special needs, are they funded? The budget is revised 3 times during the year in order to meet the needs of the schools. The Financial Resources team is in communication with administrators in case there is something that needs to be revisited.
- SEAC is hoping that a member of that group can join this focus group.
- The Terry Fox alternate would like to know if she can join this focus group. The chairperson will follow up with the member.

8.1 Anti-bullying conference

And further that the PC treasurer be authorized to sign the invoice allowing a cheque to be issued for the cost. Seconded by Laurentian Elementary.

8.2 PC Caucus

There was no caucus this evening. A guick survey was sent to the committee and a caucus will be held next Tuesday or Thursday.

8.3 Bill 96 Resolution

Was updated to reflect our PC and the changes that were brought up at the last meeting.

<u>Bill 96, An Act respecting French, the official and common language of Québec</u> is trying to override the fundamental freedoms, equality, and legal rights of Québecers. These rights are safeguarded by the Québec Charter of Human Rights and Freedoms.

Whereas the SWLSB parent's committee is very concerned for the future of our children in Québec

The restrictions being placed on all Québecers by Bill 96, violates the rights of our children.

Whereas Bill 96 restricts academic freedom by limiting your educational options

Bill 96 caps how many French-speaking students can attend an English-language CEGEP. If you are French-speaking and want to attend an English CEGEP, you could be excluded.

Whereas Bill 96 empowers the government to seize your cell phone and computer

Your work phone and computer would no longer be private. Bill 96 would give the provincial government the power, without a warrant, to seize your work phone and other equipment to verify that you are communicating properly in French.

Whereas Bill 96 reduces your ability to receive services in English

Bill 96 would give majority French-speaking municipalities the power to refuse to communicate with you in English, or to provide such services as tax bills and water-boil advisories in English.

Whereas Bill 96 overrides our human rights and freedoms

Because of the pre-emptive use of the notwithstanding clause, Québec citizens will not have recourse to the courts to enjoy their individual freedoms, and legal rights. Citizens will be powerless in defending themselves against the power of the state in the application of Bill 96.

GB20220505-04 Sainte Adele Elementary MOVED THAT the SWLSB parents' committee oppose Bill 96 on the grounds that it violates the Québec Charter of Rights and Freedoms and restricts minority rights, and that the committee send a letter to Premier Legault stating said opposition.

Be it further resolved that the SWLSB parents' committee send a copy of the above-mentioned letter to all MNAs on the SWLSB territory, and to all provincial and federal party leaders.

Be it further resolved that the SWLSB parents' committee ask EPCA to lobby the Québec government to remove all articles in Bill 96 that violate the Québec Charter of Rights and Freedoms and restrict minority rights. Seconded by Pinewood Elementary.

Carried UNANIMOUSLY

Different methods of publicity were discussed: Video snippets, YouTube, a PowerPoint presentation sent to schools to disseminate to the community, a one-page explanation document.

- PC will use the upcoming anti-bullying conference publicize GB and PC.
