2.0 Recognition – OSEntreprendre Challenge

The Chairperson informed those present this evening that, annually, the schools of the Sir Wilfrid Laurier School Board (SWLSB) participate in the OSEntreprendre Challenge, which is a provincewide contest that supports entrepreneurial development by highlighting students who carry out entrepreneurial initiatives.

At the April 29, 2022, meeting of Council, it was noted that 21 Sir Wilfrid Laurier School Board schools participated in this year's challenge. The winners at the local level in the Laurentides and Lanaudière regions were recognized at this meeting. This evening, the Council is proud to recognize the following winners from Laval of the OSEntreprendre Challenge:

- Twin Oaks Elementary School (TOES)
 - The project *Seeds of Love* won at the regional level in the Elementary Cycle 2 category;
 - The project will also be a part of the provincial challenge;
 - Karen Stoddart, Teacher, and her Earth Rangers have worked on various projects over the years to promote pollinators and the importance of them being a part of the environment. The Seeds of Love project involved spreading seeds around the school and surrounding area in order to attract pollinators and strengthen them as they will help improve fruit trees, produce gardens and flowers;
 - This project promoted teamwork, creativity, researching, planning, marketing, etc. all while fostering respect for the environment.

The Principal of TOES noted that Ms. Stoddart and the Earth Rangers are doing great work and that they have been recognized on many levels for their efforts to sensitize students to the environment.

- Laval Senior Academy (LSA)
 - The project LSA Work Study Market Place won at the regional level in the Secondary Special Education category;
 - Like the TOES project, the LSA project will also be a part of the provincial challenge;
 - Katrina Driver, Project Development Officer, and Shaunna C. Kerr and Kosta Tomazos, both Resource Teachers, worked with the students on this school-based, student-run enterprise;
 - The students make custom products that they sell to the school community, such as cutting boards and signs made out of repurposed school desks, personalized tote bags, aprons, T-shirts, etc.;
 - Ordering merchandise can be done via Instagram and e-mail;
 - The students are responsible for budgeting, quality control, managing inventory and keeping track of sales;
 - This project has allowed for the development of entrepreneurial skills in a hands-on environment.

The Resource Teachers noted that this project came together when it became necessary to have inhouse stages.

The Chairperson congratulated the teams from TOES and LSA noting that if any school or centre has something they are celebrating, the Commissioners would like to know and would be glad to attend.

The Principal of LSA commented that this project started out as a small idea and has become a big giving-back-to-the-community initiative that has grown throughout the school year. The elementary schools are even ordering items. The students are seeing the results of their labour and this is very helpful to them because there are times when they do not thoroughly understand why they need to see a project through to the end and this initiative has helped enormously.

The Resource Teachers provided background information on the project:

- The students began the project by following local businesses on Instagram;
- They researched designs online then used the Cricut to produce them as an iron-on;
- They created their own Instagram page to advertise their wares;
- They made cake toppers and sold them to local businesses;
- Tools were found in an old science lab at the school that were not being used and the students have put them to use when repurposing old desks, chairs and benches;
- The items created by students have become very popular and sometimes it is hard to keep up with the orders;
- There is a lot of math involved in the projects.

In response to questions from the Chairperson, the following was noted:

- There were ten students involved in the Market Place project;
- Over 100 orders have been filled since the project began;
- The students rent out special boards to wedding planners that are returned and the lettering replaced for the next wedding or other event.

The Pedagogical Consultant who assisted the schools with the OSEntreprendre Challenge noted that it has been a true pleasure to support and guide these teams on their respective projects. All of the students and staff are to be commended for all of their hard work on these wonderful and innovative projects as they showcase 21st century and lifelong learning elements.

- May 2 Attended a meeting with Christopher Skeete, MNA for Sainte-Rose, to discuss with him various school board dossiers, the SWLSB graduation rate, challenges being faced and Bill 96. The discussion on Bill 96 was interesting and Mr. Skeete supports the efforts to protect the French language. The passage of Bill 96 into law is sad for both the English and the French community, as it impacts everyone in some negative manner;
- May 7, 14 & 23 Attended the Star Fest rehearsals. This year's show will be excellent as another layer has been added to support the talent through a live band to accompany all of the acts. Special recognition must be given to Anthony, a student stage hand, who was present at every rehearsal to provide lighting and anything else needed. Anthony has been invited to attend the Laurier Gala and Star Fest as a guest of the school board;
- May 9 Attended the Franklin Hill Elementary School (FHES) celebration of its students and staff whose project FHES: A sustainable school in action! won the OSEntreprendre Challenge at the local level in Lanaudière. The students involved in the project taught their fellow students how to properly treat waste through sorting for recycling, composting and regular garbage;

- May 18 Attended an assembly at Grenville Elementary School with Vice-Chairperson Adam Gordon, Commissioner Donna Anber, the Assistant Director General, the Assistant Director of Pedagogical Services, the Coordinator of Communications and dignitaries from World Vision to see the school honoured for its fundraising efforts for the war in Ukraine. The school board as a whole also conducted its own fundraising and surpassed its original goal of \$25,000 by raising a total of \$44,000. All the students, school teams and parents are to be thanked for making the fundraiser a success;
- May 18 Attended the Open House at CDC Pont-Viau with Vice-Chairperson Adam Gordon, Commissioners Donna Anber and James Di Sano, as well as Saul Polo, MNA for Laval-des-Rapides and Archie Cifelli, Vice-President of the Sir Wilfrid Laurier Foundation. The Open House showcased what the CDC Pont-Viau has to offer in terms of programs, its safe and secure learning space and its students, who are dedicated and very proud of their achievements.

- Parent Commissioner Tara Anderson advised that the students of Laurentia Elementary School are working on a beautiful mural at the school with the assistance of artist Emily Read. Each student has the opportunity to contribute to the mural by adding quotes of kindness. The mural was made possible through a grant;
- Commissioner Bob Pellerin expressed his appreciation for being invited to attend the FHES celebrations of its win in the OSEntreprendre Challenge noting that it is always nice to see how proud the students are of their achievements.
