2.0 Presentation – Sir Wilfrid Laurier Foundation

The Chairperson welcomed Josée Côté, President of the Sir Wilfrid Laurier Foundation (SWLF) and a retired administrator of the school board, to the meeting noting that the Council is pleased that she could be present this evening.

He went on to provide background information on the SWLF noting that it has worked hand-in-hand with the school board to ensure that students would be the centre of its decisions when fundraising. The SWLF has also benefited over the years from having community partners such as the Caisse Desjardins Therese de Blainville, Laval News, North Shore News, Cinéma Guzzo, Barbies' Restaurant and many more.

The Chairperson invited Ms. Côté to come forward for the presentation.

Ms. Côté advised that the SWLF has been in place for 18 years and since that time has raised to \$900,000.00. With the monies raised the SWLF has given out \$285,000.00 to 1,900 students in the form of bursaries ranging from \$100.00 to \$500.00. This evening she is pleased to present the Sir Wilfrid Laurier School Board with a cheque for \$25,000.00 to be used for the purchase of bimodal equipment.
