8.2.1 Engagement of Contractor – New School in Saint-Lin-Laurentides

The Director of Material Resources and Transportation advised that all of the necessary documents have been sent to the MEQ.

WHEREAS the Sir Wilfrid Laurier School Board (SWLSB) has requested a new school for the Joliette area to alleviate overcrowding in the Lanaudière region;

WHEREAS the SWLSB has received authorization from the Ministère de l'Éducation to build a new school in Saint-Lin-Laurentides;

WHEREAS a public call for tenders was published and tenders were opened on October 19, 2022;

WHEREAS the conformability of all bidders has been verified;

WHEREAS the construction amount initially financed by the Ministère de l'Éducation for this project was of \$19,076,912.00, before taxes, and the school board was later authorized to proceed with a budget of \$22,277,540.00, before taxes;

WHEREAS, prior to the bidding process, the final estimation sent to the Ministère was in the amount of \$23,361,118.00;

WHEREAS this project includes over \$2,800,000.00 of special conditions;

Commissioner Bob Pellerin MOVED THAT, on the recommendation of the Advisory Committee - Administration and pending approval, from the Ministère de l'Éducation, of the amount submitted by the lowest conformable bidder, the Council of Commissioners of the Sir Wilfrid Laurier School Board award the construction contract for the new school in Saint-Lin-Laurentides to Consortium M.R. Canada Ltée for an amount of \$29,114,000.00, before taxes, or \$31,119,008.40, net taxes;

AND THAT the Director General or, in their absence or with their knowledge, the Assistant Director General be authorized to sign all documentation concerning this project;

AND THAT the Director of Material Resources and Transportation be authorized to sign documentation concerning this project, as per by-law no. BL2008-CA-01: *Delegation of Functions & Powers of the Sir Wilfrid Laurier School Board*;

FURTHER THAT a letter be prepared and signed by the Chairperson and sent to the Ministère de l'Éducation to request additional financing for this construction considering that the lowest conformable bidder's price is above the amount approved and financed by the Ministère de l'Éducation for this project.

8.2.2 Professional Fees – Ventilation Renovation Project – Twin Oaks ES

The Director of Material Resources and Transportation noted that a new ventilation system is being installed in the older area of the school.

Commissioner James Di Sano MOVED THAT, on the recommendation of the Advisory Committee – Student Success, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the professional fees submitted by ANA Architecture Inc. for an amount of \$147,937.37, before taxes, or \$158,125.45, net taxes;

AND THAT the Director of Material Resources and Transportation be authorized to sign all documents required in this regard.

In response to questions, the Director of Material Resources and Transportation noted that some of the older schools still have some asbestos and when significant work is done in one of those schools, it is safely removed. The asbestos removal is done when the students and staff are on summer break.
