### 4.0 Question Period

The Secretary General and Director of the Legal, Corporate and Communications Department explained the parameters of the two question periods of 20 minutes each and drew attention to where people online can type in their questions for the second question period. There were no questions for the first question period.

She noted that the second question period is for questions related to agenda items only.

### 5.0 Report from the Chairperson

The Chairperson welcomed everyone to the third meeting of the 2022-2023 school year. He went on to provide an update on Bill 40 noting that a ruling is still pending on the merits of the bill and it is hoped that, after more than a year and a half, the ruling will be in favour of the anglophone community. The Quebec English School Boards Association (QESBA) will be advised when the ruling will be deposited and he and Commissioner Donna Anber will be present as the school board's delegates to the QESBA when the ruling is read.

He continued presenting Bill C-13: An Act to amend the Official Languages Act, to enact the Use of French in Federally Regulated Private Businesses Act and to make related amendments to other Acts, which is a federal government bill that will modernize and strengthen the Official Languages Act (the Act). This bill will affect the Canadian Charter of Rights and Freedoms (the Charter) by removing all English language rights in Québec. Section 23 of the Charter has always protected the rights of the English in Québec but with these changes it will harm rather than protect. The English community needs to lobby the Canadian government to not approve Bill C-13 and everyone can do so by signing an open letter to Parliament on the Quebec Community Groups Network (QCGN). He went on to present his monthly report noting:

  - Genesis Elementary School In the morning, he attended this ceremony with Commissioner Anick Brunet and it was wonderful to see the students connect with veterans;
  - Laurentian Regional High School (LRHS) In the afternoon, along with Commissioner Donna Anber, he attended this beautiful and emotional student-led ceremony;
  - Remembrance Day is a day that allows everyone to remember the sacrifices that
    many brave men and women have made while fighting conflicts throughout the world
    for many years, so that we have the freedom we so enjoy today;
- November 10, 2022 In the evening, he attended the Laval Senior Academy Open House with Commissioners Barbara Barrasso, Vincent Cammisano and James Di Sano. It was a well-planned open house and the principal and her team are to be congratulated and thanked for this informative event;
- November 23, 2022 Attended the first game of the Sir Wilfrid Laurier School Board Elementary School Hockey Tournament at Place Bell. This is a friendly tournament between the school board's elementary schools. There will be five other games during the 2022-2023 school year.

### 9.1 Financial Resources

### 9.1.1 2021-2022 Financial Statement and External Auditor's Report

The Chairperson advised those present that the law had been followed with the publication of a public notice, a summary of the financials posted on the corporate website and both posted in the schools and centres and on their respective websites and Facebook pages.

The Director of Financial Resources presented and reviewed the audited financial statement noting that the results were positive and that the school board's accounting practices met with Canada's accounting standards.

He went on to provide an overview of the audited financial statement as follows:

- The results show a surplus of \$6,484,192.00, in 2021-2022 versus a deficit of \$14,850,444.00, in 2020-2021. This must be examined together as, in a normal school year, revenues and expenses all have to take place within the same year, which is not the case for 2021-2022, so it must be explained;
- There were approximately \$4,357,808.00 in COVID-19-related expenses and \$10,722,646.00 were related to retroactive salary adjustments due to the new Collective Agreements, which contributed to the large deficit in 2020-2021. Moving forward, there is an additional \$2,710,879.00, in COVID-19-related expenses for the 2021-2022 school year which were isolated and considered an extraordinary expense. In 2021-2022, some revenues were adjusted by directives from the MEQ that were to be applied for 2020-2021;
- Details of variances In May 2022, it was projected that the deficit would be \$551,000.00, but it ended up being \$1,666,191.00, which can be partially explained by the loss of daycare revenue, as many parents withdrew their children from the service due to COVID-19, resulting in the school board charging less than in a normal situation, and by additional transportation costs.

Parent Commissioner Stéphane Henley pointed out a small error in the total within the resolutions and everyone agreed that it should be corrected.

WHEREAS additional sensory rooms are required for special needs students who often use specific materials to practice self-regulation;

WHEREAS, in addition to the lack of appropriate space, Crestview Elementary School requires major renovations;

WHEREAS Crestview Elementary School would also greatly benefit from a bus lay-by for adapted vehicles:

WHEREAS both the SWLSB and the Governing Board of Crestview Elementary School have indicated to the Ministère de l'Éducation du Québec (MEQ), via their respective resolutions, that Crestview Elementary School has difficulty meeting the needs of the growing number of students within its existing facilities;

WHEREAS, for the Laval region, a new school to replace Laval Senior Academy High School is requested;

WHEREAS this new school is required considering the cost and extensive timeframe needed to repair, to bring up to standards and to remove all contaminants within the building;

## 13.1 Transportation Contracts - Funding

Commissioner Donna Anber expressed appreciation to the Director of Material Resources and Transportation, the Assistant Director of Material Resources and Transportation and the Coordinator of Transportation for all the work they have put into the process of renewing the transportation contracts.

The Chairperson concurred with Commissioner Anber noting that everyone involved has done an excellent job. Pressure on the MEQ now needs to take place for compensation to cover the budget shortfall that will come with the new transportation contracts.

**Transportation Contracts** 

**Funding** 

WHEREAS the five-year contracts for school bus transportation services ended on June 30, 2022, for all transporters contracting with the Sir Wilfrid Laurier School Board (the "SWLSB"), as this was the case for most school boards and school service centres in Québec;

WHEREAS the Ministère de l'Éducation (MEQ) hired a mediator in order to negotiate provincially the terms and conditions of transportation contracts with the Fédération des transporteurs par autobus (the "Federation");

WHEREAS the Government and the Federation have reached an agreement as to the financial contribution to be given to transporters for school bus transportation services;

WHEREAS, in order to avoid a breach in transportation services, the Executive Committee adopted resolutions no. EC-220829-MR-0006 and EC-220829-MR-0007, authorizing the Director General to sign all necessary documentation to extend, on a monthly basis, the contracts with all transporters offering school bus or berline transportation that agree to this monthly extension, until all negotiations are finalized provincially;

WHEREAS, if the SWLSB were to apply the new provincial agreement to its regular transportation routes, it would find itself in a deficit position because of the financial impact;

WHEREAS this provincial agreement does not apply to the contracts for berline transportation services, which will increase the overall deficit position of the SWLSB;

WHEREAS certain transportation contractors used by the SWLSB have refused the agreement negotiated between the MEQ and the Federation;

WHEREAS the MEQ has yet to confirm to the SWLSB if it will fund the additional costs that are to be incurred, notably, by this new agreement;

Commissioner Donna Anber MOVED THAT the Council of Commissioners of the Sir Wilfrid Laurier School Board formally request the Ministère de l'Éducation to confirm that it will finance any additional transportation costs to be incurred by the Sir Wilfrid Laurier School Board in the operation of its school buses and berlines:

AND THAT a copy of this resolution be sent to the Ministère de l'Éducation with a letter to be signed by the Chairperson detailing these concerns.
