#### 4.6 Professional Fees

In response to a question from the Vice-Chairperson, the Director of Material Resources and Transportation noted that when a project is planned, professional fees are estimated as closely as possible, but given that a firm cannot estimate on what it cannot see through the walls, this often results in increased fees.

WHEREAS the mechanical engineering firm Bouthillette Parizeau Inc. was engaged to prepare plans and oversee the ventilation renovation project at Twin Oaks Elementary School and had submitted their service offer with their professional fees of \$72,100.01, before taxes;

WHEREAS, given the existing structure of the building, additional charges were incurred due to the increased complexity of the project, which had an impact on the final estimate of the professional fees;

WHEREAS, due to these additional charges, the professional fees of Bouthillette Parizeau Inc. increased from \$72,100.01, before taxes, or \$77,065.36, net taxes, to \$108,488.08, before taxes, or \$115,959.38 net taxes;

Commissioner James Di Sano MOVED THAT, on the recommendation of the Director of Material Resources and Transportation, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the increase in professional fees submitted by Bouthillette Parizeau Inc. from \$72,100.01, before taxes, or \$77,065.36, net taxes, to \$108,488.08, before taxes, or \$115,959.38, net taxes:

AND THAT the Director of Material Resources and Transportation be authorized to sign all documentation regarding the above-mentioned professional fees.

#### 4.6.2 Architecture – New School in Saint-Lin-Laurentides

In response to a question from the Vice-Chairperson, the Director of Material Resources and Transportation noted that, similar to the increase in the architectural fees, the mechanical and electrical engineering fees are estimated. The professional fees are estimated when requesting a project from the Ministère de l'Éducation (MEQ) and are then adjusted before the project goes to tender because some unknowns have been found. The MEQ regulates the cost of professional fees.

AND THAT the Director of Material Resources and Transportation be authorized to sign all documentation regarding the above-mentioned professional fees.
