2.0 Recognition – OSEntreprendre

The Chairperson informed those present that annually, many of the Sir Wilfrid Laurier School Board schools/centres participate in the OSEntreprendre Challenge/Québec Entrepreneurship Contest which acknowledges the entrepreneurial talents of students across the province. This school year, 17 schools and centres participated in this challenge and this evening the Council would like to recognize Twin Oaks Elementary School (TOES) and Joliette High School (JHS) for winning at the local level in Laval and Lanaudière, respectively.

Twin Oaks Elementary School won for the Laval region in the Elementary level, 1st Cycle, Grades 1 and 2 Category for its Nature of Kindness Ornaments that were made by Sheryl Cree's Grade 2 classes with the aid of Gloria Luca, Attendant, who are with us this evening along with TOES Vice-Principal, Antoinetta Caprera.

Throughout the school year, Ms. Cree's Grade 2 class participated in several kindness projects which involved acknowledging and appreciating the acts of kindness by individuals. The students left scarves in a tree in the park, made sandwiches for the less fortunate and designed the kindness ornaments from branches they collected. The OSEntreprendre was unanimous in the selection of this initiative.

Ms. Cree thanked the Chairperson for his words and thanked the TOES administration for its support of these initiatives and, especially, the students for their dedication and creativity. The project was submitted in the hopes that it might win a monetary prize that can be used for future projects.

Congratulations to everyone involved.

Joliette High School won for the Lanaudière region, in the high school level, 2nd Cycle Category, for its Talent Show. With us this evening are Ruby Emond, CLC Community Development Technician; Amanda Guerrero, Teacher, and Stephane Néron, Special Education Technician; Sébastien Neveu, Principal; and several students.

During this past school year, the Secondary 4 and 5 students have volunteered at La Soupière–Joliette, a local soup kitchen that serves meals and provides food baskets to those in need. When planning the talent show, it was realized that while this would be a fun community event it was also an opportunity for it to be a social awareness project because the funds collected through ticket sales and snack bar sales could be used within the Joliette community.

Carrefour Jeunesse Emploi d'Autray-Joliette, the school's community partner, assisted the 14 students involved with the show by guiding them through the details of planning, set-up, management, budgeting, ticket sales marketing and promotion of the event, to name a few.

The efforts of all involved with the Talent Show paid off because JHS won \$5,000.00, all of which was donated to La Soupière–Joliette.

TOES and JHS are to be commended for their initiatives and entrepreneurial acumen. Both schools have demonstrated creativity, generosity, empathy and creating a positive impact through a pay-it-forward approach.

Ms. Emond noted that the Talent Show was a great collaboration between everyone involved and that it could not have been achieved without the dedication of M. Néron throughout the school year. JHS is regaining its school culture as it had been almost three years since the Talent Show had been presented.

As the Council representative for JHS, Commissioner Bob Pellerin noted, it was an honour to observe the students and the staff of the school come together to present this wonderful Talent Show and everyone is to be congratulated.

In response to a request from Commissioner Melissa Wall, the Chairperson invited the JHS students and staff attending via Zoom for comments.

The Principal of JHS noted it was a wonderful way for the students to raise money for the community and when the cheque was presented to La Soupière–Joliette, all the students were present.
