The Chairperson welcomed everyone to the first meeting of the Council of Commissioners for the 2023-2024 school year noting that he hoped that everyone had had a restful and pleasant summer. He went on to present his monthly report noting:

- June 22, 2023
  - Attended the Morin Heights Elementary School closing ceremonies with Commissioner Donna Anber;
  - Attended the Laurentia Elementary School graduation ceremonies with Commissioner Donna Anber and Parent Commissioner Tara Anderson. The graduation was especially meaningful for the principal, Karen Moore, who was retiring;
  - Attended the Ste-Agathe Academy Graduation of the Class of 2023 with the Interim Director General, Commissioner Donna Anber and Parent Commissioners Chloée Alary and Tara Anderson;
- June 29, 2023 – Attended the CDC Pont-Viau Graduation with Commissioner Barbara Barrasso, Parent Commissioner Tara Anderson and the Interim Director General. It is always an honour to be present at this graduation;
- July 2-5, 2023 – Attended the Canadian School Boards Association Conference in Banff, Alberta. The conference provided a multitude of information on Indigenous education, diversity and inclusion. As this report is being made, it is Truth and Reconciliation Week

and the schools and centres of the Sit Wilfrid Laurier School Board are celebrating and taking part in activities that will help build and equitable future;

- August 2, 2023 – The Québec Superior Court ruled on Bill 40 and in favour of the anglophone community as it deemed that there were many elements, especially the right to control and manage schools, of the Bill that were unconstitutional. The Québec Government is appealing this historic decision that highlights the importance of linguistic minorities within the province. This appeal is disappointing because the decision was well reasoned, but the anglophone community will continue to fight for its rights;
- August 16, 2023 – Joined the Management Team at Pinewood Elementary School for lunch and spent part of the afternoon in the welcome back workshop;
- August 25, 2023 – Participated in an interview on CBC Daybreak Montréal on the challenges facing school boards and school service centres with the lack of teachers;
- August 29, 2023 – Met with the Députée de Chomedey, Sona Lakhoyan Olivier, concerning the Air Cadets in Laval as being the only anglophone group in the area;
- August 30, 2023 – It was back to school at Arundel Elementary School and he attended with the Interim Director General. While there, he joined students in a basketball game. Best of luck to the principal, staff and students for a great 2023-2024 school year;
- August 31, 2023 – Attended back to school activities with Commissioners Barbara Barrasso, Bob Pellerin and the Interim Director General at Laval Junior Academy, as well as Mountainview and Rawdon Elementary Schools where a warm welcome by all was received;
- September 5, 2023 – Attended the official photo call for the launch of the Rentrée scolaire 2023 Bus Safety Program with the Police de Laval and the Centre des services scolaire de Laval. The theme this year is *Drop Me Off Safely*;
- September 7, 2023 – Laurentia Elementary School's Welcome Back was held and its new principal, Josée Fortin, showed her school spirit by being one of the dunk tank targets, the teachers were the others. Parent Commissioner Tara Anderson was also present as a parent and a member of the Council;
- September 15, 2023 – There were many activities that he attended along with Commissioners Barbara Barrasso and James Di Sano and the Interim Director General. The first were the welcome back events at St-Vincent and Genesis Elementary Schools followed by the Laval Senior Academy (LSA) Homecoming.

- September 23, 2023 – Attended the Franklin Hill Elementary School 20<sup>th</sup> Anniversary and Welcome Back event with Commissioner Bob Pellerin and Parent Commissioner Tara Anderson, along with the Deputy for Repentigny and a representative of the Repentigny Municipality Council. It was a wonderful barbeque and the school community is to be congratulated on a great celebration.

- Commissioner Olivia Landry noted that McCaig Elementary School had held its welcome back on September 21, 2023, and that it was a really nice event.

### **6.0 Report from the Interim Director General**

The Interim Director General welcomed all stakeholders to the 2023-2024 school year noting that it has had a very good start. He went on to highlight his monthly report noting:

- The new school project in Saint-Lin-Laurentides is moving along very well and is on target for opening in the fall of 2024. The walls will be up as soon as the structure is completed so that interior work can take place during the winter months. The school will have 16 classrooms to house 350 students;
- The Commitment-to-Success Plan (CTSP) has been updated with the recommendations received from the Ministère de l'Éducation and the school board is now awaiting final approval so that it can be launched to the public. The target for the launch is the October 25, 2023, meeting of council. The CTSP focuses on students, employees and bilingualism. The schools will be aligning their respective Educational Projects with the new CTSP;
- Student *Wins*:
  - In mid-August, the kindergartens 4 and 5 students received by mail a welcome postcard that they could colour and return to the school board;
  - It was really nice to see that at all of the back-to-school celebrations held between August 30 and 31, 2023, that he attended with the Chairperson of the Sir Wilfrid Laurier School Board and other commissioners, students were genuinely excited to return to school;
  - The LSA Homecoming was special in that it is nice to see two of the school board high schools supporting each other;
- Upcoming Dates:
  - October 18, 2023 – The inauguration of the outdoor classroom at Ste-Agathe Academy will take place. This outdoor classroom was an initiative by a teacher and the CLC Coordinator at the school that began before COVID. The project was resurrected last year in partnership with the MEQ, Fondation Tremblant and the school board;
  - Open Houses will be held on October 18, 19 and 24, 2023, at Laval Senior Academy, Rosemère High School and Laval Junior Academy, respectively;
  - The new initiative to honour retirees and regular employees of more than five years, the Milestone Gala, will take place on October 26, 2023.

The Chairperson noted that the open houses at the schools are very important events because each school has the opportunity to showcase what the Sir Wilfrid Laurier School Board has to offer. He encourages everyone to attend.

WHEREAS on an annual basis the government allocates funds to school boards to help build and enlarge schools and centres;

WHEREAS school boards must present their request through the Plan Québécois des Infrastructures (PQI) on a yearly basis;

WHEREAS the priority needs of the Sir Wilfrid Laurier School Board (SWLSB) have been evaluated;

WHEREAS, for the Laval region, a new school adapted to its special needs students is requested;

WHEREAS this new school is essential considering the insufficient space to service the students of Crestview Elementary School, most of whom have complex physical, intellectual, emotional and social needs;

WHEREAS larger classrooms are necessary to properly service these students who require many resources and adapted materials;

WHEREAS additional rooms are required to enable the professional staff, including speech-language pathologists, occupational therapists and psychologists, to properly assist these students;

WHEREAS Crestview Elementary School lacks a sufficient number of adapted washrooms for students requiring specific hygiene measures;

WHEREAS additional sensory rooms are required for students with special needs who often use specific materials to practise self-regulation;

WHEREAS, in addition to the lack of appropriate space, Crestview Elementary School requires major renovations;

WHEREAS Crestview Elementary School would also greatly benefit from a bus lay-by for adapted vehicles;

WHEREAS this new school is required considering the cost and extensive timeframe needed to repair, to bring up to standards and to remove all contaminants within the building;

WHEREAS the project would consist in building a new school on the existing property, followed by the demolition of the old one;

WHEREAS, one (1) new school is requested in the Laurentides region for sector 6 in order to alleviate the current overcrowding at St-Jude and Mountainview Schools and to respond to the forecasted student enrollment in the region;

WHEREAS the Governing Boards of St-Jude and Mountainview Schools have indicated that their respective schools are operating at overcapacity;

WHEREAS, for the Laurentides region, Ste-Adèle Elementary School does not currently have a gymnasium;

WHEREAS, the PQI 2024-2034 includes the request of the construction of a gymnasium for the students at Ste-Adèle Elementary School;

Parent Commissioner Chloée Alary MOVED THAT, on the recommendation of the Advisory Committee – Student Success, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve the construction of one (1) new school in the Laurentides region, one (1) new school in the Laval region, one (1) replacement in the Laval region and the construction of a gymnasium in Ste-Adèle Elementary School as part of the PQI for 2024-2034;

AND THAT the director of Material Resources and Transportation be authorized to complete any paperwork required to submit this PQI 2024-2034 request to the Ministry of Education.
