0.0 Opening of Meeting

0.1 Acknowledgement of the Land

I would like to honour the existence of the First Peoples by acknowledging that the Sir Wilfrid Laurier School Board is on the traditional land of the Kanien'keha:ka or Mohawk nation.

The Mohawk Nation is also known as the "Eastern Door Keepers" and are a member of the Haudenosaunee Confederacy which also includes the Seneca, Cayuga, Tuscarora, Onondaga and Oneida Peoples.

In the spirit of truth, reconciliation, and collaboration, we honour our relationship with the Indigenous Community and respect the history, culture, and language of Canada's original peoples.

The Chairperson advised that today is National Indigenous Peoples' Day, a day to recognize and celebrate the First Nations, Inuit and Métis, their history, heritage and diversity throughout Canada. It is also the time to recognize the forced assimilation, cultural suppression, poverty, violence against women and systemic racism that the Indigenous Peoples' have faced over many years and the continued need for truth and reconciliation.

The education system plays a crucial role in striving to achieve truth and reconciliation therefore, indigenous languages and cultural practices should be integrated into schools. The Sir Wilfrid Laurier School Board has implemented *First Nations and Truth and Reconciliation Studies* for elementary and high schools and has also partnered with *The Gord Downie & Chanie Wenjack Fund* to help build connections through education.

A minute of silence was held for those who have been victims of colonization and discrimination.

2.0 Recognition – Pedagogical Services

The Chairperson noted that the Council is pleased to recognize the achievements of Leo Scharley and Seth Mayo, Students at CDC Lachute Charlene O'Hanley, Teacher and Mélanie Bujold, Social Services Officer, in obtaining a \$10,000.00, grant from the *IT GETS BETTER CANADA* for LGBTQ+ initiatives within the school board. Recognizing these efforts in June is particularly special in that June is Pride Month, a month when everyone comes together to celebrate and support the LGBTQ+ community.

Ms. Bujold is a champion of the LGBTQ+ students within the school board and as a Social Services Officer she assists the schools in creating an inclusive environment where all students feel valued, supported and safe to be their true selves.

Ms. O'Hanley, Leo Scharley and Seth Mayo collaborated with Ms. Bujold on the project for the grant application and it was selected by the *IT GETS BETTER PROJECT* review committee. The project submitted fits with the mission of the *IT GETS BETTER PROJECT* to uplift, empower, and connect two spirits, lesbian, gay, bisexual, transgender, and queer (2SLGBTQ+) throughout the country through community building and storytelling.

The grant will provide CDC Lachute and the nine high schools of the school board with \$500.00, starter kits for LGBTQ+ clubs. These kits will play a vital role in establishing safe spaces within schools where students can find support, engage in meaningful dialogue, and promote equality and inclusivity. It will also allow for a series of speakers, the addition of LGBTQ+ books to high school libraries and the acquisition of items that will further promote visibility and pride within the Sir Wilfrid Laurier School Board community.

4.0 Question Period

The Interim Secretary General and Director of the Legal, Corporate and Communications Department explained the parameters of the two question periods of 20 minutes each and drew attention to where people online can type in their questions for the second question period.

5.0 Report from the Chairperson

The Chairperson welcomed everyone to the last Council meeting of the 2022-2023 school year noting that the past year has had its challenges but that through collaboration and resilience it was a successful one. He is sure that everyone is looking forward to a well-deserved summer break.

He went on to present his monthly report noting:

- June 5, 2023 – Attended the press conference for *Il faut que je te raconte*, with the Assistant Director General. This contest is held to promote the French language through storytelling and is open to the elementary and secondary students as well as CEGEP students. All entries are due by January 7, 2024;
- June 5, 2023 – Attended the *Model the Way Honours* ceremony at Colossus Laval. This evening is held to celebrate the success of students that participate in Leadership in their schools and communities. Approximately 150 students from grade five to secondary V from eleven Sir Wilfrid Laurier School Board (SWLSB) schools were recognized. Congratulations to the Pedagogical Services team who heads up this project with the students and staff of the schools. The Caisse Desjardins de Chomedey is a partner in this project;

Student Representative, Hareem Saad Nawaz, noted that this evening was a very nice way to show appreciation to students that raise their voices for others. All who participated deserved this honour.

- June 7, 2023 – Attended the hearing in the National Assembly on Bill 23 with Commissioner Barbara Barrasso and representatives of the Quebec English School Boards Association (QESBA). The QESBA deposited its brief on Bill 23 and presented the injustices this bill brings notably the government being able to appoint director generals of the English school boards and francophone Centres de services scolaire (CSS) and giving the government the power to annul a decision taken by a school board or a CSS. The purpose of the QESBA is to advocate for the appropriate education for students in the youth and adult sectors;
- June 8, 2023 – Attended the Sir Wilfrid Laurier Foundation (SWLF) Lobster Gala. The event was a success with \$30,000.00, raised for the purchase of sensory equipment for the schools. The SWLF took the opportunity to introduce its Ambassadors Club for which more details will be provided in the fall of 2023;

Commissioner James Di Sano, as a member of the SWLF, noted that the Ambassadors Club is an initiative for the financing of future projects to give back to the schools.

7.1 School Zones for the New School in Saint-Lin-Laurentides, Franklin Hill, Joliette, Laurentia, Pierre Elliott Trudeau, Pinewood and Rawdon Elementary Schools

WHEREAS the Sir Wilfrid Laurier School Board (SWLSB) requested a new school for the Joliette area to alleviate overcrowding in the Lanaudière region;

WHEREAS the SWLSB received authorization from the Ministère de l'Éducation du Québec to build a new school in Saint-Lin-Laurentides;

WHEREAS a school attendance zone needs to be established for the new school in St-Lin-Laurentides;

WHEREAS the Council of Commissioners adopted resolution no. CC-221114-TS-0024 authorizing the consultation of all concerned stakeholders in particular those of Franklin Hill, Joliette, Laurentia, Pierre Elliott Trudeau, Pinewood and Rawdon Elementary Schools (the Schools), on the geographical area that will be serviced by the new school in Saint-Lin-Laurentides;

WHEREAS on November 29, 2022, the Sir Wilfrid Laurier School Board held a public consultation with all stakeholders to present the attendance zone for the new school in Saint-Lin-Laurentides and the impacts on the attendance zones of the Schools, as shown in document no. SWLSB-2023/05/31-TS-001;

WHEREAS the consultation documents were published on the Sir Wilfrid Laurier School Board website and provided to the Governing Boards of each of the Schools;

WHEREAS the public consultation ended on March 17, 2023;

WHEREAS the Directorate and the Council of Commissioners have reviewed the feedback and recommendations received;

Commissioner Barbara Barrasso MOVED THAT, on the recommendation of the Advisory Committee – Administration and Advisory Committee - Student Success, the Council of Commissioners of the Sir Wilfrid Laurier School Board approve that, as of January 1, 2024, the following sectors be removed from their respective school attendance zones and be included in the school attendance zone for the new school in Saint-Lin-Laurentides:

- Saint-Calixte, Saint-Esprit, Saint-Lin-Laurentides, Saint-Roch-de-l'Achigan, Saint-Roch-Ouest (formally part of Joliette Elementary School's attendance zone), Sainte-Sophie (East of Montée Morel) (formally part of Laurentia Elementary School's attendance zone), Sainte-Anne-des-Plaines (formally part of Pierre Elliott Trudeau Elementary School's attendance zone), La Plaine (Terrebonne) (formally part of Pinewood Elementary School's attendance zone), Sainte-Julienne (South-West of), Saint-Calixte-North, (formally part of Rawdon Elementary School's attendance Zone) as shown in document no. SWLSB-2023/05/31-TS-002;

AND THAT as of January 1, 2024, the following sectors be removed from Joliette Elementary School and added to the attendance zone of Franklin Hill Elementary School:

- l'Assomption, l'Épiphanie, Lavaltrie (South-West of), Saint-Sulpice, as shown in document no. SWLSB-2023/05/31-TS-003;

AND THAT as of January 1, 2024, the following sectors be removed from Franklin Hill Elementary School and added to the attendance zone of Pinewood Elementary School:

- Îles St-Jean, Old Terrebonne, Terrebonne (East side of highway 25) as shown in document no. SWLSB-2023/05/31-TS-004;

AND THAT the attendance zones of Franklin Hill, Joliette, Laurentia, Pierre Elliott Trudeau, Pinewood and Rawdon Elementary Schools be modified in order to reflect the aforementioned modifications;

AND THAT, should the opening of the school be delayed beyond September 2024, the students that are in the sectors that will make up the school zones for the new school in Saint-Lin-Laurentides, Pinewood Elementary School and Franklin Hill Elementary School will remain in their current schools;

AND THAT when the opening date of the new school in Saint-Lin-Laurentides is confirmed, the sectors above be removed and added as indicated;

FURTHER THAT transportation will be organized and provided by the Sir Wilfrid Laurier School Board.

- the rate of \$0.0973 per \$100 of the assessment set by the Minister for the 2023-2024 school tax;

8.2 General Directorate

8.2.1 Commitment-to-Success Plan 2023-2027

The Chairperson advised that the adoption of the 2023-2027 Commitment-to-Success Plan (CTSP) represents the cumulative collaboration that took place over the 2022-2023 school year. The Sir Wilfrid Laurier School Board (SWLSB) can be proud of its 88.3 percent graduation and qualification rate as can all of the students, teachers, parents, and all employees who have contributed to this success. The SWLSB is filled with optimism with the new objectives and orientations of the CTSP and is committed to the collective goal of an inclusive and supportive educational environment.

He extended thanks to all stakeholders who have participated in the creation of this new CTSP that embraces and fosters the culture of learning.

The Coordinator of Communications presented the CTSP noting that some of the priorities of the SWLSB were similar to those of the Ministère de l'Éducation so they were selected as the three orientations:

- Orientation 1: Students – To support and increase the success of diverse learners and at-risk students academically, socially and emotionally;
- Orientation 2: Employees – To attract, retain and support quality employees;
- Orientation 3: Bilingualism – To ensure all students possess strong bilingual competency and proficient French skills by the time they graduate, enabling them to thrive in Québec.

She went on to present the final visual for the new CTSP noting that it was presented to the Advisory Committee – Administration for feedback which has been incorporated. The new visual was designed as follows:

- A tree to represent growth;
- Coloured leaves for diversity, LGBTQ+;
- A youth and an adult who represent all levels of learning;
- The roots for the stakeholders that support the school board.

The three orientations are represented in different colours with the employees being defined in red because they are the heart of the school board.

The Chairperson went on to welcome and congratulate Josiane Fortin to her new position as Principal of Laurentia Elementary School noting that she lives in the community and has an understanding of the stakeholders.
