## 2.0 Recognition - Crestview

The Chairperson welcomed everyone to this evening's meeting noting that tonight the Council of Commissioners would like to recognize those who had contributed to bringing to fruition the *Communication Boards' Project* at Crestview Elementary School (CES).

The *Communication Boards' Project* is the brainchild of a parent and a Special Education Technician at CES after seeing the original vinyl language communication board in a magazine article. The pair brought the idea to the CES Home and School, who saw the benefit of such a project and invested the \$3,000.00, required to make the boards.

The *Communication Boards*, which are bilingual, were unveiled on April 9, 2023, with one board in the school yard and three in key locations within the school building. The boards have pictures, symbols and words that will help non-verbal or minimally verbal students to communicate.

He extended congratulations, on behalf of the Council of Commissioners, to the CES Home and School for undertaking this project that will help enhance the learning experience of the students, with special mention to the President of the CES Home and School. He also thanked a community member who was able to secure a donation from the Hellenic Women's Federation of Laval and who also donated three of the smaller communications boards.

The school team at CES is seeing a very positive impact on the students with the installation of the communication boards.

The Chairperson invited Irene Tsimiklis, Principal; Sheila Lindsay, Special Education Technician; Vasiliki Psychoyos, Attendant; Nathalie Seupanya, Governing Board Chair and President of the CES Home and School; and Spiro Pettas, Community member, to the front to be recognized for this amazing initiative.

## 3.0 Signing of the LTU Local Arrangements

The Chairperson invited the members of the Laurier Teachers' Union to come forward for the signing of the amended Local Arrangements. The amendments to bring the recall procedures for Adult Education and Vocational Training in line with those of the youth sector were approved on June 21, 2023. This evening is the formality of signing the said amendments to the Local Arrangements.

The Interim Director General thanked everyone involved in the negotiation of these amendments notably the Assistant Director of Human Resources.

#### 4.0 Official Launch of the 2023-2027 Sir Wilfrid Laurier School Board Commitment-to-Success Plan

The Chairperson of the Sir Wilfrid Laurier School Board welcomed everyone to the official launch of the Sir Wilfrid Laurier School Board's 2023-2027 Commitment-to-Success Plan (CTSP) noting that this will be the guide to student success over the next four years. It has been developed with the Sir Wilfrid Laurier School Board's (SWLSB) mission and core values. The initial CTSP was adopted on June 21, 2023, and sent to the Ministère de l'Éducation (MEQ) for approval. The MEQ returned it with its recommendations and the final version of the CTSP was adopted on September 27, 2023. On September 28, 2023, the Sous-ministre congratulated the school board on its great work and gave approval of the CTSP.

The approval by the MEQ of the 2023-2027 CTSP is a testament to the dedication of all internal and external stakeholders who helped shape it, especially the CTSP working table. The school board is committed to ensuring that all stakeholders are kept up to date on the progress of the CTSP through the year.

The Interim Director General noted that the school board is proud that many stakeholders participated in the consultation process because their input helped create the declaration of services for the next four years, which is in line with the mission and vision of the school board. The declaration of services, while dedicated to all stakeholders, is student-focused and strives to provide a positive climate where everyone feels safe, respected, nurtured and accepted while recognizing the uniqueness of all individuals; the declaration of services also promotes consistent, transparent and honest communication with everyone while ensuring honesty, integrity and accountability in all undertakings from employees and commissioners. The Sir Wilfrid Laurier School Board has an 88.3 percent graduation and qualification rate that makes it number one in the Laval, Laurentides and Lanaudière regions and in the top ten within the Québec.

The Interim Assistant Director General advised that the MEQ Strategic Plan sets the orientations and objectives for all educational institutions. This school board has selected students, employees and bilingualism as its three orientations and there are nine objectives between these three orientations. She reviewed the challenges faced by the school board and the need to gather precise data on what can be done to alleviate these challenges:

- At-risk students;
- School climate;
- Employee recruitment, retention and professional learning;
- Effects of the COVID-19 pandemic;
- Equity, diversity and inclusion;
- Data-informed decision-making; and
- School life and community relationships.

The Director of Pedagogical Services presented the CTSP indicators noting that the first MEQ objective is for 86.8 percent of the student population to receive a first diploma by 2026-2027. This school board is already ahead of the game with its current graduation and qualification rate of 88.3 percent and is hoping to achieve 89.9 percent by 2026-2027.

She noted that the first four CTSP indicators are academic, followed by modernizing and enhancing vocational training, development of new educational projects and improving the climate of caring, well-being and safety for students.

She went on to advise that the results of the CTSP will be monitored over the next five years with a focus on:

- Fostering a culture based on data and research;
- Basing decisions on evidence-based research and data;
- Evaluating the results and impacts of various initiatives;
- Implementing a culture of data that will provide valuable insights into student progress;
- Fostering a collaborative environment where stakeholders can work together in achieving the goal of improving student success.

The Coordinator of Communications presented and reviewed the branding of the 2023-2027 CTSP noting that the tree represents strength, growth and unity; the trunk the school board's core values, the colourful leaves represent all of the stakeholders, diversity and inclusivity. The two people sitting underneath the tree are non-gender to represent equality and, again, inclusivity.

The visuals can be used in different ways with the goal being to have people remember the three orientations Learn, Work, Grow or Students, Employees and Bilingualism, given that stakeholder feedback showed that with the last CTSP not many stakeholders were aware of the five objectives. All branding will be bilingual and Communications is developing promotional tools for use by all the schools, centres and the head office.

The Interim Director General thanked the Director of Pedagogical Services, the Director of School Affairs and School Organization, the Director of Information Resources, the Centre Directors, respectively, of Adult Education and Vocational Training; the Principals of Hillcrest Academy and Saint-Agathe Academy, the Coordinator of Communications, the former Director General, Gaëlle Absolonne, and retired Director of Pedagogical Service, Geoffrey Hipps, for bringing the 2023-2027 CTSP to life.

The Chairperson thanked everyone who participated in this CTSP for a job well done.

Leaving is bitter-sweet but he is leaving the department in the capable hands of his successor and the competent Financial Resources team.
