8.2.2 Public Presentation of the 2022-2023 Annual Report

The Chairperson opened the public presentation of the 2022-2023 Annual Report of the Sir Wilfrid Laurier School Board by welcoming everyone to the meeting and stating

"As per article 220 of the Education Act, every school board and school service centre shall prepare an annual report giving its stakeholders the data about its Commitment-to-Success Plan and the results obtained in each of its objectives.

The annual report is an opportunity to look back at our results, analyze our data and make sure that we are in line with our school board objectives as well as targets set by the Ministry of Education. This year's report once again focuses on some of the many highlights and achievements of the last year of the 2018-2022 Commitment to Success Plan.

This annual report is a testimony to the incredible work that has been accomplished last year. When you read the report, you will see for yourself why the Sir Wilfrid Laurier School Board, ranks among the top 10 school boards across Québec and first in the LLL region.

I would like to bring your attention to some of the many highlights you can find in the Chairperson's message on pages 3 and 4.

We are proud to report that our graduation and qualification rate has increased to 88.3%. This progress is encouraging as it means we are on track to reach our target of 89.9% by 2027. The closer we get to this target, the more challenging it is, but we are confident that we will achieve it.

This graduation rate is a testament to the efforts and creativity deployed by everyone at the school board in keeping our students engaged and focused on the important goal of graduating.

Since 2017, the student population at Laurentia Elementary School in Saint-Jérôme has consistently been growing. There was a pressing need for additional space. To ensure our students had an optimal learning environment and more specifically, more space; we leased and renovated a building adjacent to the school and created 3 additional classrooms, an office space for professionals and additional parking. Our teams worked tirelessly during the year to make sure the new building was ready for the start of the 2023-2024 school year.

In April 2023, we began the construction of our new elementary school in Saint-Lin-Laurentides to alleviate overcrowding in our Lanaudière elementary schools. This new school will have a capacity of 384 students, 16 classrooms, 8 collaborative rooms, 1 library, 2 sensory rooms, a double gymnasium, and so much more.

This multimillion-dollar project required two public calls to tender due to the initial bids exceeding the budget authorized by the Ministère de l'Éducation. Alongside the tendering process, we conducted a town hall meeting to present the proposed attendance zone for the new school. Stakeholders of the six schools impacted by rezoning were consulted. This collaborative effort led to the adoption of a final school attendance zone at the June 21, 2023 Council meeting.

Another major undertaking was the development of the new Commitment to Success Plan. The CTSP working table comprised of stakeholders from schools, centres and departments, conducted a detailed survey to collect feedback and suggestions, receiving input from over 2,300 stakeholders. Through meticulous analysis, three orientations and nine strategic objectives emerged.

This concerted effort highlights our unwavering commitment to excellence, ensuring that the CTSP serves as a guiding light for the success and growth of every member of our community.

The Central Students' Committee led by Commissioner James Di Sano, met 3 times over the course of the 2022-2023 school year, reinforcing student involvement in our decision-making processes. Topics discussed during these meetings included financial literacy, fostering student leadership and involvement, environmental issues and ways to increase psychological support resources and physical activity within our schools. Commissioners Olivia Landry, Vincent Cammisano, and Stéphane Henley, as well as 6 students are part of the central students' committee."

The Chairperson invited the Assistant Director of Pedagogical Services, the Director of Material Resources and Transportation and the Director of Financial Resources to make their respective presentations.

The Assistant Director of Pedagogical Services presented and reviewed the Pedagogical Services piece of the Annual Report as follows:

Objective 1: By 2030, reduce the gap in success rates between various groups of students by 50%

- The school board has been able to reduce the gap in success rates between boys and girls by 7.2 percent since 2020;
- The gap in the graduation rate between students with and without an Individual Education Plan (IEP) has increased by 10.6 percent. Even with this increase, the school board is within 1.8 percent of meeting the target set in 2022. Additional work is required;
- The socio-economic gap is one of the biggest challenges. In 2021, the gap was 16.3
 percent, most probably due to the effects of the pandemic, but the school board is pleased
 to note that it is within 6.1 percent from meeting the 2022 target of 10.2 percent;

Objective 2: By 2030, reduce to 10% the proportion of students starting public secondary school at age 13 or older

• The 2022 results indicate that the proportion for the Sir Wilfrid Laurier School Board (SWLSB) is 3.3 percent. The school board's target was to keep the proportion below 5 percent and this is being achieved. Overall, the school board consistently outperforms the rest of the province:

Objective 3: By 2030, have 85% of students under the age of 20 obtain a first diploma (SSD or DVS), and 90% obtain a first diploma or qualification

 The graduation rate has been stable over the past two years and the current results show that the SWLSB is far ahead of the provincial average as well as surpassing the 2022 graduation rate of 88 percent;

Objective 4: By 2030, increase to 90% the success rate on the composition component of the Elementary 6 (Cycle 3, Year 2) language of instruction ministerial examination in the public system

 Provincially there is no baseline or target for this objective because only French mother tongue (FLE) exams are considered. The school board set a target of achieving a 90 percent success rate for language of instruction by 2030 and has now exceeded it by 4 percent. English Language Arts and French Second Language are a strength of the school board.

The Assistant Director of Pedagocial Services turned the presentation over to the Director of Material Resources and Transportation.

The Director of Material Resources and Transportation commented on the following:

Objective 5: By 2030, ensure that all school buildings are in good condition

- The age and condition of the school board buildings represent a challenge and upgrades to the buildings are undertaken annually in accordance with the funding available;
- In 2022, the ministry introduced the GIEES (Gestion des infrastructures de l'Éducation et
 de l'Enseignement supérieur) system to replace SIMACS. All buildings of the SWLSB
 were inspected in accordance with the new GIEES parameters and the results are
 currently being analyzed. This new system allows for a better identification of the priority
 of need.

The Director of Material Resources and Transportation turned the presentation over to the Director of Financial Resources.

The Director of Financial Resources presented the finance statement of principle for the 2022-2023 school year noting that \$259,176,182.00 in revenues was received versus \$227,453,377.00 in expenses leaving an accounting surplus of \$31,722.805.00. The surplus is due to the Asset Retirement Obligation (ARO) that has had an effect on the entire public sector. More detailed information of the 2022-2023 financial results can be found on the corporate website where the financial statements are posted.

The Chairperson thanked Assistant Director of Pedagogical Services, the Director of Material Resources and Transportation and the Director of Financial Resources for their respective presentations. He also thanked, on behalf of the Council of Commissioners, all Sir Wilfrid Laurier School Board employees for making a difference every day so that the students can thrive and be successful.

In closing, he thanked the commissioners for the continued support and dedication to English public education and to this school board.
