#### 4.0 Question Period

The Secretary General and Director of the Legal, Corporate and Communications Department explained the parameters of the two question periods of 20 minutes each and drew attention to where people online can type in their questions for the second question period.

She noted that the second question period is for questions related to agenda items only. Question period is not a platform for debate.

The Secretary General and Director of the Legal, Corporate and Communications Department advised that a few questions have been received for this first question period from Renata Isopo.

The Secretary General and Director of the Legal, Corporate and Communications Department proceeded to read the questions received and the Chairperson addressed said questions as follows:

**Question 1:** Could you please give an update of the Heritage school regarding completion of the construction and are the students being fully serviced with a cafeteria, gymnasium, and school yard for their leisure time.

**Answer:** Construction is completed, and students are being fully serviced with a finished cafeteria, gymnasium and school yard.

Only a few minor corrections need to be finalized, but none that have an impact on services to students.

Pictures of the completion of Heritage Elementary are in the DG's report this evening.

**Question 2:** The last Chairperson stated that 200 air purifiers were installed in certain schools, and that another 600-800 were ordered for installation. Could you please give the name of the schools which already have the installation and have the remaining number 600-800 (please clarify number) been installed and in which schools? What was the cost for the air purifiers and installation.

**Answer:** Our Material Resources Department installed 222 air purifiers. The cost is approximately \$700 before taxes per unit, including installation.

The schools at which we installed these units are the following:

- Pinewood Elementary
- Twin Oaks Elementary
- Genesis Elementary
- Sainte-Adèle Elementary

No other air purifiers were installed as they were not deemed necessary.

**Question 3:** Is Rosemere High getting air purifiers or air conditioners (please clarify)? This was stated at the last Council meeting at a cost of over 1.5 million dollars. Considering this large sum, could you give a breakdown of the costs incurred?

**Answer:** The Council resolution authorized an expenditure of approximately 1.5 million for the replacement of the existing ventilation system of the school as well as the cleaning of the ventilation ducts. A detailed breakdown of the costs cannot be given as this may be considered confidential information belonging to a third party.

**Question 4:** What is the procedure (directives) in applying the collective agreements and working conditions regulations with the employees and school administrations? Are long term and day-to-day substitute teachers included in these directives?? What are the directives and which policy dictates the directives?

**Answer:** Human Resources is responsible for the training, support, interpretation, and application of the provincial and local agreements with administrators.

It is part of every administrator's role to apply the rules and procedures in effect.

For short-term replacements: The provincial agreement defines the rights and benefits of substitute teachers whereas the local agreement includes the procedure and the order to follow when hiring these short-term replacements.

For long-term replacements, the provincial agreement details the rights, benefits and procedure to follow.

**Question 5:** How many of the board's permanent employees are working in classrooms. In previous research into this "issue" you were informed that the number of teachers in classroom was between 850 and 900. Is that a close approximation of this classroom teacher cohort? If not, what is the exact figure?

**Answer:** We have just over **900 E1** teachers in the youth sector. We also added approximately 80 teachers on contract this year, who hold regular posts but are assigned to replacements for most of them. In addition, we have approximately **425 other employees** such as attendants, school and daycare educators, special education technicians and "aide à la classe" employees in our classes (including permanent or not).

#### 5.0 Report from the Chairperson

The Chairperson welcomed everyone to the meeting noting that it is a privilege to be present this evening for his first official Council meeting since the new Council was sworn in. He is very grateful to be able to lead a team that is committed to student success and community engagement.

He went on to quote Christine Grégoire saying *Education is the foundation upon which we build our future*. These words describe the mission of the Sir Wilfrid Laurier School Board (SWLSB) because this school board wishes to invest in the future by supporting innovative programs, providing support to the passionate educators, and empowering all of its students to excel.

He further noted that the Council members will be pleased to attend events hosted by the school communities of the SWLSB.

The Chairperson presented his report noting his attendance at the following events and thanking those Commissioners and members of the Directorate who accompanied him:

- November 9, 2024 Attended the Remembrance Day Ceremony at Ville de Laval;
- November 19, 2024 Attended SWLSB's Retirement Celebration and Milestone Gala;
- November 30, 2024 Had milk and cookies with Santa at Pinewood Elementary School and visited the Jules Verne Elementary School holiday market;
- December 1, 2024 Attended the Mother Teresa Exhibition at Laval Junior Academy;
- December 6, 2024 Visited the Saint Paul Elementary School Holiday Pop-up Shop;
- December 7, 2024 Visited the Holiday Markets at Our Lady of Peace and Saint Vincent Elementary Schools.

He congratulated all of the students, staff, parents and principals for all of the hard work put into making these events fun and successful.

Several meetings were also attended in November and early December.

The Chairperson also issued statements on the occasions of National Day of Remembrance and Action on Violence Against Women on December 6, 2024, and International Human Rights Day on December 11, 2024.

#### Community Highlights

- Commissioner Bob Pellerin advised that on November 28, 2024, he attended the Joliette High School craft fair and pasta night and it was very enjoyable;
- Parent Commissioner Tara Anderson noted that Laurentia Elementary School held its first post-COVID craft sale on November 23, 2024. She also announced that Laurentia would be holding a poker night on January 31, 2025;
- Commissioner Donna Anber attended the Laurentian Regional High School's Remembrance Day ceremony with Parent Commissioner Chloée Alary. She also attended a ceremony at Sainte-Agathe Academy with Parent Commissioner Tara Anderson;
- Commissioner Barbara Barrasso advised that she has represented the SWLSB on behalf
  of the Chairperson at the Italian Chamber of Commerce Award Ceremony. She also
  attended the Remembrance Day ceremony at Terry Fox Elementary School.

#### 6.0 Report from the Director General

The Director General provided an overview of what has taken place since the last meeting of the Council noting:

- Meetings and events:
  - He presided the Remembrance Day ceremony at the Head Office on November 11, 2024. He noted that he was moved by the number of employees that attended and their connections to the ceremony;
  - He has visited six schools to date as part of the school visits program that he splits with the Assistant Director General. He thanked their shared Administration Officer for scheduling these visits;
  - He attended the Retirement and Milestone Gala where retirees and long-time employees were honoured;

- He attended meetings with counterparts in the Laval-Laurentides-Lanaudière region and other school boards;
- He attended the Forum des directeurs généraux meeting with representatives from the Ministère de l'éducation and the Colloque de la Fédération des Centres de services scolaires du Québec:
- He was present at the Governance Alignment Program workshop with the Council;
- He attended virtual meetings with the Ministère de l'Éducation;
- He attended the Parents' Committee meeting;
- The official September 30 enrolment figures have been received and enrolment has
  decreased by 113 students from last year for a total of 12,681. This is not something we
  like to see as it impacts financing, but it is less than one percent of the enrolment.
  Communications is working on a marketing plan that will be presented in the new year;
- The Québec government decreed a hiring freeze as of November 1, 2024, with the
  exception of Directors General and positions that provide direct services to students,
  including all in-school positions. This hiring freeze means that new positions, vacant
  positions and replacement of future vacancies cannot be filled until, at least, March 31,
  2025, unless from within the school board and with exceptions granted by the Conseil du
  Trésor;

#### Proud Moments:

- The construction of Heritage Elementary School is now complete;
- The annual Retirement Dinner and Milestone Gala. This event is funded through a government measure;
- The interim Principal of Mountainview High School secured a grant that allowed members of the school team to visit Kuujjuaq from November 2 to November 6, 2024;
- Mountainview Elementary School received a grant to support its indigenous students;
- Business Services has a new website for workplace training. The school board often uses their services for training;

# 8.1.1 2023-2024 Financial Statements and Auditor's Report

The Director of Financial Resources advised those present that the 2023-2024 financial statements and auditor's letter were presented and reviewed on November 27, 2024, at a meeting of the Advisory Committee – Administration in the presence of the auditor.

The audited reports covered the audit of the school board's clientele and the auditor's qualified opinion deemed that the school board is declaring its clientele in the proper manner and that it is following the proper accounting standards. These reports also cover the procedures on specific information requested by the MEQ.

The financial statements show that the school board ended up with an accounting surplus of \$1,715,835.00, but adjustments related to the previous school year, such as reinstatement of the previous year due to the Asset Retirement Obligation, the eight-day teachers' strike, and the retroactive salary adjustments from the new collective agreements, etc., resulted in an adjusted surplus (deficit) of \$646,223.00.

Engagement of Service Providers – Local Recruitment Agencies for Vocational Training WHEREAS the Sir Wilfrid Laurier School Board wishes to establish partnerships with local recruitment agencies to assist with the enrolment of local students for its vocational training courses;

WHEREAS, as per the *Regulation respecting certain service contracts of public bodies*, an authorization is required for every contract of a repetitive nature whose expected term, including any renewal, is greater than 3 years;

WHEREAS, as per the *Regulation respecting certain service contracts of public bodies*, a public body may enter into a task order contract with one or more service providers when the procurement requirements are recurrent and the number of requests, the rate or frequency at which they are to be performed are uncertain;

WHEREAS public call for tenders no. 24-203-01 was published for local recruitment agencies for vocational training and the bids were opened on November 15, 2024;

WHEREAS the conformity of all bidders has been verified;

WHEREAS the task order service contract is adjudicated to all service providers who submitted an acceptable tender and requests are made to the service provider who submitted the lowest price (remuneration percentage), unless the provider cannot perform the service, in which case the other providers are solicited according to their respective rank;

WHEREAS the Council of Commissioners must approve this task order service contract as its value was estimated at more than \$250,000, as per by-law no. BL2023-CA-01 *Delegation of Functions & Powers of the Sir Wilfrid Laurier School Board*;

Commissioner Heather Appleby MOVED THAT, on the recommendation of the Advisory Committee – Student Success, the Council of Commissioners of the Sir Wilfrid Laurier School Board award the four-year task order service contract (2 years + 2 optional periods of one year each) for local recruitment agencies for vocational training as follows:
