0.1 Acknowledgement of the Land

- May 17, 2025, was the International Day Against Homophobia, Biphobia and Transphobia. The school board reaffirmed its commitment to fostering safe, inclusive, and respectful environments for all stakeholders as there is no place for discrimination in the SWLSB schools, centres and communities.

4.1 Community Highlights from Commissioners

- Commissioner Désirée Ramacieri congratulated Heritage Elementary School on its Art Show which was a stunning exhibition of creativity. The school staff and principal are to be congratulated on the organization of this event;
- Commissioner Barbara Barrasso advised that the Parents Participation Organization at Laval Senior Academy had organized a Zumbathon and that it was an evening full of smiles and laughter;
- Parent Commissioner Chloée Alary advised that on May 8, 2025, Laurentian Regional High School held its annual dance show and it was a lovely evening with an array of beautiful costumes. Besides the dance show, the school also displayed student art and the graduating class held a bake sale.

5.0 Report from the Director General

The Director General presented his monthly report noting the following:

- Visits to schools and centres: Forty-seven visits have been completed to date by the Assistant Director General and himself;
- Attended the following meetings: English school boards, Management, Parents' Committee, Forum des DG, the AAEQS–QESBA Spring Conference, career meetings with in-school/centre administrators, and a special General Assembly of the ADGSQ;
- An information session for future administrators was held on May 7, 2025. There was a good turnout of people interested in becoming leaders in education;
- The Joliette High School Golf Tournament was held on May 24, 2025. The day was enjoyable and it was nice to see former students come out to help raise money for school activities;
- The enrolment numbers have shown a modest decline over the past few years, but things are starting to improve. As of May 21, 2025, enrolment stands at 12,647 students in the youth sector which is only 34 fewer students when compared to 2024-2025.

The targeted registration campaign which allowed Communications to use data from the Canadian Census was a success. This campaign helped recruit 60 new students so this registration strategy will be repeated.

A closer look at leavers will be undertaken in order to collect data as to why they leave the SWLSB between elementary and high school.

- Administrative assignments for 2025-2026
 - The selection process for the position of principal at Crestview Elementary School is underway;
 - Recruitment of two vice-principals at Rosemère High School and a one-year principal replacement at Saint-Vincent Elementary School are also in progress;
 - The General Directorate is looking to have stability in the schools and centres therefore, no additional permanent assignment changes are expected in 2025-2026.
- 2025-2026 Budget
 - The MEQ budget parameter package has not yet been received so the school board has no funding information for the coming school year. Initial documents have been received with respect to teacher staffing and salaries and it is hoped that the remainder of the budget parameter package will follow shortly;
 - As the budget parameters have not been received, the 2025-2026 budget will not be presented to Council until its September meeting;
 - Challenging financial times are anticipated.
- Proud Moments
 - Inauguration of Heritage Elementary School. It was an honour to have the Ministre de l'Éducation, Bernard Drainville, present at the event. M. Drainville was very friendly, charismatic, and very good with the students with whom he spoke at length;
 - Model the Way. The SWLSB extends its gratitude to Senator Tony Loffreda, an exceptional role model for the leadership group, who generously took the time to mentor them.
- Upcoming Events
 - On May 29, 2025, the annual Laurier Gala and Star Fest will take place, and the performances are sure to be spectacular;
 - On June 5, 2025, the Sir Wilfrid Laurier Foundation's annual Lobster Gala will take place.
- Vocational Training
 - On September 1, 2025, the *Stationary Engine Mechanics* DVS program will begin and run until January 22, 2027;
 - In September 2025, a Skills Training Certificate in *Support for Assistive Services in Health and Social Service Institutions* will begin.
