3.0 Question Period

The Secretary General and Director of the Legal, Corporate and Communications Department explained the parameters of the two question periods of 20 minutes each and drew attention to where people online can type in their questions for the second question period.

She noted that the second question period is for questions related to agenda items only. Question period is not a platform for debate.

Two questions have been submitted for the first question period by Jessica Thibault Côté.

1. Why do people who have no teaching related experience/education see before qualified people for every job? (le. always the same time gap and they are ahead)? Doesn't this go against the collective agreement?

The Chairperson noted that, for now, as per the board's past practice, all substitute teachers will continue to be considered in the same tier. The school board's procedures fully respect the collective agreement. This being said, the Human Resources Department may review this practice in the next few months to ensure the best support to our school and students.

2. There are some people with qualified and/or who have teaching related experience/4th year university students whose accounts still don't work. Scolago confirmed it is not on their end. I have sent proof of preferred lists not working for the past two weeks to the school board and all I keep getting is "we will assess the situation." Why did someone who is unqualified (no teaching/teaching education experience) get their account fixed before me even though she wrote after me?

The Chairperson advised that the Human Resources Department is answering all requests as quickly as possible. Considering the high volume of requests, the Human Resources team is currently experiencing delays for certain requests that are more complex than others. We thank everyone for their patience and understanding in this regard. The teams will get back to you as quickly as they can.

4.0 Report from the Chairperson

4.2 Community Highlights from Commissioners

- Commissioner Barbara Barrasso noted that she had attended the Curriculum Night at Laval Junior Academy and that it was a very nice experience because the school had organized it so that the parents were able to meet with all of the teachers who teach their children;
- Commissioner Heather Appleby attended the Rosemère High School graduation ceremony on September 20, 2025, with the Chairperson and Commissioner Benny Catania;
- Commissioner Désirée Ramacieri advised that she had attended the inauguration of the new location of the Centre de pédiatrie sociale en communauté d'Argenteuil. This group has been a long-time partner with the SWLSB. She also reminded everyone of the LRHS Annual Golf Tournament being held on Saturday, October 11, 2025. The proceeds raised at this event are used to enrich student life at the school.

5.0 Report from the Director General

The Director General advised that the Assistant Director General sends her regrets for this evening's meeting as she is representing the school board at the CDC Pont-Viau graduation.

He went on to present his monthly report, noting the following:

- Since the opening of the 2025-20265 school year, there have been three school/centre
 visits, six visits to welcome students, parents, and employees on their first day of school
 and attendance at two graduations, undertaken by either the Assistant Director General or
 himself;
- Meetings with the Ministère de l'Éducation six meetings through the Forum des DG and one meeting between the MEQ and the SWLSB, all related to the 2025-2026 budget. The six meetings were held to clarify certain aspects of the budget;
- Acted as a moderator on a panel at the Bishop's Forum for young leaders. It was a case study on community reaction to the government's Bill 40;
- The recent school bus transportation issue evolved as follows:
 - The Director General was advised at 10:35 p.m. on September 11, 2025, that the Lion electric buses belonging to companies that transport for the SWLSB were being removed from service for inspection;
 - This notice was received three hours after two of the SWLSB's sister school boards received the message;
 - The suspension of the electric buses affected 17 bus routes serving 11 schools for a period of two days;

- On Tuesday, September 16, 2025, a partial resumption of the electric buses occurred with full service being restored on September 17, 2025;
- The SWLSB transporters and the transportation team at the school board all deserve special thanks for their hard work and patience during this disruption.

2025-2026 Budget

- In June 2025, the preliminary budgetary rules were received and required the SWLSB to cut over \$12,000,000.00;
- On July 16, 2025, the official MEQ budgetary rules were received and these new rules
 reduced the amount for the SWLSB was to cut to \$3,700,000.00. This will still make
 budgeting challenging because these final rules were received after many of the
 assignments and hiring decisions had already been made, making any changes
 difficult. The departments are all looking at what can be contributed to these cuts;
- The MEQ has added a new control mechanism to cap the number of remunerated hours for all school boards and centres de services scolaires. Everyone will have to track these hours so that they are not exceeded. If exceeded, there will be significant financial consequences.

2025-2026 Projected Enrolment

- Projected enrolment, as of September 10, 2025, currently stands at 12,512 students, which is a decrease of 113 students when compared to the 2024-2025 enrolment;
- The enrolment is being watched closely to see why it continues to decrease, especially in the Laval elementary schools.

Proud Moments

- On September 6, 2025, he was in attendance at the SWLSB Game Day with the Montreal Alouettes and was pleased to have taken part in the presentation of bursaries from the team to one student from Laval Junior Academy and another from Laval Senior Academy;
- Delphine Labonté, a student at LRHS, was the recipient of a \$1,500.00, bursary from Fondation Le But and Fondation Aléo;
- Francesco Vignone, a former student at Saint-Vincent Elementary School and a current student at Laval Junior Academy, gave an excellent performance on Quel talent! a Québec based talent search;
- Lina Hadid, a graduate of CDC Pont-Viau in Starting a Business, was recently featured on City News for the resilience she has shown as a Syrian-Canadian immigrant, a cancer survivor and an entrepreneur, who has launched her own natural skin care line. She will be a guest speaker at part 2 of the CDC Pont-Viau graduation on October 2, 2025;
- A heartfelt thank you goes out to all of the SWLSB support staff for National School Support Staff Week for all they contribute to education no matter the job they do.
